

## **U.S., Indians Enter Historic Settlement**

After nearly 14 years of litigation, three Presidents, four Interior Secretary's, two judges and scores of lawyers, the federal government and more than 300,000 Individual Indian Money (IIM) beneficiaries have come to a settlement in a lawsuit that claims that the federal government mismanaged individual Indians' trust accounts for over 100 years.

Plaintiffs, Elouise Cobell, Earl Old Person, Mildred Cleghorn, Thomas Maulson and James Larose filed the original complaint in 1996 in the United States District Court in Washington D.C. The case was originally assigned to the Honorable Judge Royce C. Lamberth who presided over the case for over 10 years.

Lamberth wrote in an opinion that "I have never seen more egregious misconduct by the federal government" and later wrote in another opinion "Now, at the conclusion of the

second contempt trial in this action, I stand corrected. The Department of Interior has truly outdone itself this time......it is a dinosaur – the morally and culturally oblivious hand-me-down of a disgracefully racist and imperialist government that should have been buried a century ago."



Judge Lamberth was removed by a federal appeals court in 2006 at the request of the U.S. Government. He was accused of being bias against the government. The case was then assigned to Judge James Robertson.

The settlement, announced on December 9, 2009, calls for \$1.4 billion to be divided among more than 300,000 people, the descendants of Indians to whom the government assigned plots of Tribal land under an 1887 law. An additional \$2 billion was agreed upon to buy back as many as 37,000 acres of subdivided Indian lands.

The settlement must be voted on by Congress and approved by Judge, Robertson.

This settlement is with individual Indian account holders and has no affect on the Cow Creek Tribe. As you know, the Cow Creeks were ignored by the federal government for over 128 years from the signing of the Treaty in 1853 until federal restoration in 1982. During that time the Tribe had no assets managed by the Bureau of Indian Affairs. However, there are some enrolled Cow Creek Tribal members who have IIM accounts for assets that were passed down to them from ancestors of other Tribes.

# What is Attention Deficit Disorder (A.D.D.)?

First of all, what isn't A.D.D.? It isn't a bad, lazy, or stupid child. It has nothing to do with how hard your child tries to be successful. It's not your child's fault if they have A.D.D. And it's not bad parenting.

What is A.D.D.? It is the inability of your child's brain to focus on what is relevant in his/her environment. It's

sort of like an electrical short circuit in a radio or cell phone that is not plugged in correctly or properly charged. It involves the neurotransmitters (electrical transmissions) in the brain; all of the parts are probably there, but the connections aren't working right.

A child with A.D.D. often has difficulty in school due to this inability to determine what is relevant in the

classroom and what isn't. The overhead lights may have a buzzing sound that you can't hear, but your child may. Your child may be very bothered by the child sitting six seats over who is tapping her finger on her desk. Your child may be agitated by the sound of the teacher helping another student. Sounds in the hall, the classroom next door, people at recess, and any movement or change may vie for your child's focused attention. Everything seems equally important to your child and he/she cannot select what to pay attention to. Your child may often be impulsive and may have difficulty making good choices, even when he/she wants to. Your child may often have

difficulty with how he/she interacts with other children. Boys with A.D.D. are often aggressive and are reported to be on-the-go all of the time. Girls with A.D.D. are often withdrawn. A child with A.D.D. typically feels bad about him/herself and, as a result, may have low selfesteem.



The diagnosis for A.D.D. cannot be made by you or your child's teacher. A Qualified Mental Health Professional (Q.M.H.P. - Psychiatrist, Psychologist, Social Worker, Behavioral Health Therapist, etc.) may use the information that you and the teacher provide, as well as how your child acts, to determine a diagnosis of A.D.D. This information should include specific behaviors, actions, activities, and sounds that your child makes. The teacher can offer information on your child's interactions with other children. There are assessment tools that a Q.M.H.P. may use to make a diagnosis of A.D.D. Two such tools are the Conner's Rating Scale and the Taylor Hyperactivity Screening. A child that is under age five is typically not able to be diagnosed with A.D.D., even though they have many of the symptoms, as small children make lots of noises, are impulsive, and distractible as part of their developmental age.

What can you do if your child has

A.D.D.? If your child does have A.D.D., there are strategies he/she can learn from a Q.M.H.P. to help them cope. Examples are: you can teach your child to purposely make eye contact, in a mindful way, when someone is talking to them. Your child may want to sit in the front row in school to help eliminate distractions. You may want to watch what your child eats and drinks, some children may be sensitive to dyes, sugar, or other additives and these may worsen your child's

symptoms. If your child continues to struggle, you may want a medication evaluation by a doctor. There are safe and tested medications that may allow your child's brain to plugin more clearly and aid him/her with relevance and attending.

A.D.D is not much different from any other physical problem or illness. It can be treated. If you suspect that your child may have A.D.D., contact Lee Van Beuzekom, L.M.F.T., at the Cow Creek Health and Wellness Center at 672-8533 and request an assessment.



## **Medicare Part B Reimbursement Benefit**

If at any time during the 2009 calendar year **Medicare Part B** premiums were withheld from your Social Security benefit, you may qualify for reimbursement from the Tribe. Tribal members aged 65 or those receiving disability payments are eligible for Medicare Part B insurance.

At the end of each calendar year, the Social Security Administration (SSA) sends recipients a SSA-1099 form for tax purposes that details social security benefits. According to the Social Security Administration, the SSA-1099 forms for year 2009 will be mailed to recipients by the last week of January 2009. In order to expedite premium reimbursement, please mail a **copy** of the SSA-1099 to the Government offices. Reimbursement checks will be distributed upon receipt of this information. To request an SSA-1099 or 2009 Benefit Statement, please contact your local Social Security Administration office.

If Medicare Part B premiums were paid for you through a retirement account, pension fund, or by some other means, you may still be eligible for reimbursement. Please provide proof of payment.

Tribal members also have the option of receiving monthly reimbursement for Medicare Part B premiums. If you would like more information regarding this program or have questions, please contact Jennifer Boettcher, Assistant to the Health Director at (541) 672-8533.

### **Contract Health News**

**2010 APPLICATIONS ARE DUE NOW**. It is hard to believe another year has gone by. If you have not received an application and live within the seven county service area, contact Contract Health Service at 541-672-8533, option 1, for an application. By Federal regulation, applications are required each year for each individual using CHS prior to a PO being issued to assure eligibility for services.

Please call 1-2 business days, in advance, for purchase orders. It is important to know the name of the business that you are going to, as most doctors and dentists are listed under the business name and the location of the business (name of the town). It is the Tribal member's (parent or guardian's) responsibility to call for their own purchase orders before each visit.

If you receive a statement and it does not show the payer of last resort (CHS) information, call the provider and give them our address and telephone number so they can bill CHS. This will speed up payment and keep you from receiving late payment notices and/or bad debt letters.

Remember: Use urgent care services when available and only use the Emergency Room for true emergencies as CHS is required to request chart notes for all ER visits to determine true emergency. If a visit was not deemed a true emergency, it is the patient's responsibility to pay the bill.

Please call us with any and all questions so we can pay your PO approved bills in a timely manner.

# **Tribal General Council Meetings Set for 2010**

All General Council Meetings will be held at 10:00 a.m. at the Cow Creek Tribal Government Offices located at 2371 N.E. Stephens Street, Roseburg, OR.

The Procedures for the nominations for the Tribal Board of Directors Election are as follows: Any registered voter of the Tribe present at the May meeting each year may nominate. Each person may nominate one individual for the election in August. When nominations are closed, no other nominations will be accepted. A nomination will be considered complete when the nominee has accepted the nomination in writing. Nomination acceptance forms will be furnished to all candidates represented at the meeting.

For those nominees not present, forms will be mailed to them no later than (3) days following the Nominations Meeting and must be received in the Tribal Government Office no later than June 10th. Candidate acceptance forms will be placed on the ballot in the order the

nominations are made. Ballot packets, including instructions, will be mailed out to registered voters of the Tribe from the Siletz Agency around July 15<sup>th</sup> and are due back to the Siletz office by August 6<sup>th</sup>. Any new voter registration card needs to be completed by May 14, 2010. Tribal members are encouraged to maintain an updated registration card including an updated signature.

# State of the Beaver Conference 2010 – February 3<sup>rd</sup> – 5<sup>th</sup>.

Inherently, all things "Cow Creek" always seem to be perceived "grand in scale." The Tribe, in collaboration with the South Umpqua Rural Community Partnership and The Beaver Advocacy Committee have planned and organized "The State of the Beaver Conference" at Seven Feathers Convention Center on February 3<sup>rd</sup>-5<sup>th</sup> to address issues of concern regarding beavers. This event is certain to adhere to grand expectations we have all come to expect of Tribal Events.

Historically beavers thrived to the point of maximum capacity within our aboriginal homelands. The entire State of Oregon (before it became a state) was abundant with beavers. Because of their abundance, as well as people's desire to associate with the animal's ingenuity, intelligence, and industry led to Oregon being known as "the Beaver State." Unfortunately, the arrival of fur trappers signified a start to their decline.

Beavers are a "Keystone Species" that play a major role in our land's biodiversity of which other species rely upon in part or entirely for their own survival. Beavers have positive effects on the vitality of salmon and their skills as "nature's engineers" also play a major role in the retention of water, which is an increasingly sought after commodity.

To some, beavers are simply seen as unwanted rodents, killed for their pelts and/or harming trees (that have commercial value) which is in discordance with human development or progress. For these reasons among others, their numbers have significantly declined through time to the point of being listed as federally threatened.

The issues surrounding beavers are unquestionably controversial, economically relevant, and increasingly important necessitating this event. It's noteworthy that the Tribal Board of Directors is co-sponsoring the event which will facilitate critical discussions and provide a forum to discuss these difficult issues. Conference presenters are the most highly prominent, world-renowned and forward thinking authorities from the international environmental community on beavers.

# Reminder: Oregon's New Cell Phone Law was effective January, 2010

This is a reminder that Oregon's new cell phone law goes into effect January 1<sup>st</sup> 2010. This law prohibits all drivers from using a mobile communication device while operating any type of motor vehicle. A mobile communication device is defined as "a text messaging device or a wireless, two-way communication device designed to receive and transmit voice or text communication".

Under the new law, if you are **over the age of 18, you may** use a wireless device if you are using a hands free accessory that allows you to keep both hands on the wheel while you are driving. This could be a Bluetooth Head Set or a Hands Free Car Kit that can be purchased at any major department store. Drivers that are **under the age of 18 may not** use a wireless device in any case except for an emergency situation or farming/agricultural operation. For more information on this law, go to the State of Oregon Website and read Oregon House Bill 2377.
