

2009 ANNUAL PROGRAMS REPORT—Part I

The Cow Creek Band of Umpqua Tribe of Indians administered many programs for the benefit of Tribal membership in 2009. The Health, Social, Education and Housing programs expended more than \$11.7 Million for the direct and collective benefit of Tribal members and their families.

Aid to Tribal Government -(ATG)

The ATG program was utilized mainly for planning, realty services (land into trust), Tribal enrollment, elections and inventory. Tribal staff focused their efforts to plan, forecast and coordinate activities to develop and maintain Tribal properties and all necessary related projects of the "land into trust" process. In 2009 there were an additional 1,814.40 acres placed in trust for the tribe.

BIA Housing Improvement Program- (HIP)

In 2009 there were 18 units available for Tribal housing in the Taylor Street Housing Development. Of these units, all were occupied by Cow Creek Tribal members. An addition of four home purchased on Pamela Court are also occupied by Tribal members. Rental amounts for these properties are determined individually, based on income. Twenty one Tribal members were assisted through the Tribal Housing Program with 10 down payment assistance grants and 11 home repair grants. Qualified applicants to the program are eligible for up to \$3,500.00. Total expenditures for 2009 in the Tribal Housing Program were \$62,392.43.

<u>Student Rental Assistance</u> – This program was developed in November 2009 and can assist eligible, full time Tribal students with rental assistance. Students can receive up to a \$250 monthly stipend. This is limited to eligible applicants on a first come, first serve basis.

<u>Tribal Rental Assistance</u> This program was developed in November 2009 and is for Tribal members who meet HUD Income guidelines that live in a home owned by the Tribe (that are not HUD Homes) to help subsidize the rent.

Education Programs -(Adult Vocational Training, Adult Education, Higher Education and Johnson O'Malley)

The 2009 Education Program saw a significant increase in the number of Tribal students seeking training and higher education. A record \$373,035.78 was expended on 80 Tribal members through the various education programs. These students entered programs to receive certificates, associates, bachelors and masters degrees in such fields as Medical Office Technology, Welding, Accounting, Nursing, Social Work, Biology, Ecology, Business, Environmental Science, Management, Medical Imaging, Radiology and dozens more. Over 55 Tribal children, ages 3-18, enjoyed multiple JOM events throughout the year.

Tribal Human Services Program

The Tribal Human Services Program encompasses Social Services, Indian Child Welfare, Family Preservation, System of Care, Low Income Home Energy Assistance, Child Care Assistance, Social Service Block Grant, Tribal Elders Program and Project Warmth. The Human Services Department provided assistance to Tribal members through home, hospital and agency visits. Tribal Human Services Staff provided liaison services between Tribal families and outer agencies.

The Indian Child Welfare Act is a law to protect the interests of Indian children when subject to state child welfare issues. There were 25 Tribal Indian Child Welfare Cases (ICWA) in 2009 throughout Washington, Oregon, Nevada and Georgia. Thirteen children were placed in adoptive homes or were placed with a guardian.

Low Income Home Energy Assistance Program (LIHEAP)

In 2009, forty-one families received LIHEAP assistance for energy assistance in the seven county service areas. Twelve families were assisted outside the service area. In addition to the financial assistance, information packets including budgeting tools were provided to individuals and families in an effort to help them take control of their own possible energy crisis situations.

Child Care Assistance Program

Last year, 20 families received assistance through the Child Care Program. Recipients utilized this program that provided quality child care while attending work, specialized training, or college. This program provides assistance on a structure payment scale dependent upon the family's income. Also provided through this program is assistance for the child care providers of Tribal children to attain CPR and First Aid certification.

Social Service Block Grant Program (SSBG) - Parenting Program

Funds derived from the SSBG program were utilized in 2009 to provide parenting packet information and presentations to Tribal families via the Family Outdoor Recreation and Fishing Day held at Diamond Lake, OR and the Summer Time Movie Club held in Roseburg, OR. Approximately 200 Tribal members were assisted through these activities.

Family Preservation and Support Services (FPSS)

Fifty Tribal families were assisted with funds from the FPSS program which were used to augment the SSBG program to provide parenting class costs.

Cultural Development Program

During 2009, continued efforts were placed on further expanding cultural educational opportunities. During the annual Cow Creek Culture Camp, a traditional salmon ceremony was held in addition to demonstrations and instruction given to Tribal families on traditional preparation of salmon. Collection of baskets, regalia, hunting and fishing gear are continuing and being developed as a living display housed in the Cow Creek Government Office. This display is being utilized to teach Tribal children and the community the hunting and subsistence methods of the tribe. Many of these items have been taken to local schools for cultural education presentations. Efforts continue to acquire and expand authentic and replicated artifacts as well as arts and crafts to be displayed. Tribal cultural staff has also started a drumming and singing group that meet on a bi-weekly basis.

Natural Resources Program

In 2009, the natural resources program continued restoration of Jordan Creek Tribal property by maintenance of planted native vegetation, new riparian native vegetation plantings, control of invasive weeds, and maintenance on in stream structures. Bureau of Indian Affairs Wild land Urban Interface funds were used for fuel reduction of 54 acres and the development and implementation of a Tribal burn plan. Water quality testing to ensure water flowing through Tribal property is contaminant free and further build Tribal capacity continued throughout 2009. NR staff worked with Page 2

Oregon Department of Fish and Wildlife and Umpqua Fisherman's Association to acclimate steelhead smolt on Tribal property, and their release into the South Umpqua River. NR Staff consulted with Oregon Department of Transportation, Oregon Department of Fish and Wildlife, Roseburg and Medford Bureau of Land Management and Umpqua National Forest on projects affecting Tribal lands or resources. Our Natural Resources Director represented the Tribe on the local watershed board, Partnership for Umpqua River's board of directors. NR staff participated in the Natural Resources Working Group government to government relation quarterly meetings to facilitate better consultation between tribes and state agencies.

Archaeology

There have been numerous projects prompting, site evaluations, and excavations that have taken place in 2009. These sites are also being monitored when construction activities are in progress. Staff continues to maintain close relationships with the Oregon Department of Transportation, The Army Corps of Engineers and the Forest Service as related to the archaeological concerns. Archaeological staff has been scanning site files for a data share agreement with the Bureau of Land Management.

Cow Creek Health and Wellness Center (CCHWC)

During 2009, a total of 630 Tribal patients made 4,560 visits to the Cow Creek Health and Wellness Center. This figure includes Cow Creek Tribal members and other federally recognized Indians as well. The clinic is staffed with the following providers and healthcare workers: Nurse Practitioner, Nurses, Certified Medical Assistant, Phlebotomist, Podiatrist, Psychologist, Psychiatrist, Nutritionist, Health Educator, and an Alcohol and Drug Counselor.

Joslin Vision Network (JVN) Teleophthalmology Program

In 2009, Cow Creek Tribal Health Clinic staff provided eye exam screenings for diabetic retinopathy abnormalities in 33 patients. The screenings take place in the Tribal clinic, but results of the exam are read and analyzed by Indian Health Services at the Phoenix Indian Hospital Ophthalmology Department in Phoenix, Arizona.

Heartsaver/Healthcare Provider/First Aid Course

The Cow Creek Health and Wellness staff offered various certification courses for Tribal members and staff during 2009. The classes provided were the Heartsavers CPR classes, First Aid classes and Health Care Provider classes.

Cow Creek Contract Health Program (CHS)

In 2009, the Cow Creek Contract Health Services staff issued over 5100 purchase orders totaling \$608,016.71 for Tribal members utilizing the program. Contract Health Service is funded through the Indian Health Service and is restricted to the Tribal service area as mandated by federal regulations. This program has eligibility requirements and requires prior approval before each visit to any provider outside the Cow Creek Health and Wellness Center.

Diabetes Prevention Program (DPP)

This program is designed to identify pre-diabetic patients, provide education and support to make lifestyle changes that will help prevent diabetes and the complications associated with the disease. In 2009, approximately 25 patients participated in either individual appointments or group classes, which included exercise, meal planning and nutrition and healthy lifestyle choices.

Behavioral Health Program

During 2009, an average of over 40 patients/families received counseling services each month from the Cow Creek Health and Wellness Center. In addition to direct services to Tribal members, the Behavioral Health Department was active as part of the Diabetes Management Team as well as provided oversight and facilitation of the Juvenile Crime Prevention Grant.

Maternal Child Health Program

The goals of the Maternal Child Health Program are to educate and provide learning opportunities for children and-pregnant mothers, specifically in dental health care. In 2009, more than 120 Tribal members and their families participated in the program.

Nutrition Program

The Nutrition Program provides services to 154 diabetic patients annually. This program is not just for diabetic patients, but addresses obesity and cholesterol issues as well. Some activities provided in this program range from individual counseling to cooking classes, community walk/runs, lunch and learn programs, and the Fall Dog Show for patients to show off the uniqueness of their K9 companions.

Cow Creek Medicare Part B Reimbursement Program

Unlike Medicare Part A, which covers a wide range of hospitalization and inpatient services, nearly everyone that has Part B coverage must pay a monthly premium. Medicare Part B is additional coverage to assist eligible recipients to pay for doctor's services, outpatient, and other medically necessary services that are not covered under Part A. This premium is usually deducted from Social Security Income and is the amount that is reimbursable by the Tribal program.

In 2009, there were 78 Tribal members who participated in the reimbursement program for a total of \$92,088. This program offers the option of a monthly or annual reimbursement. Those that chose an annual reimbursement totaled 56, while 10 members requested a monthly reimbursement. This program has no service area restriction and 12 members did not respond in regard to benefits.

Tribal Dental Health Program (TDHP)

The Tribal Dental Health Program provided all enrolled Tribal members, regardless of where they reside, a \$1,500.00 benefit in dental care services that included preventative care, fillings, extractions, root canals and crowns. During 2009, 391 Tribal members utilized this program for a total amount of \$227,679.64. There were also 7 Tribal members that were fitted for dentures. (Cosmetic procedures and implanted teeth are not covered under this benefit)

Over the Counter Program

In 2009, the Cow Creek Health and Wellness center processed over 753 purchase orders for the Over-The-Counter Program. Over 479 Tribal members residing within the Tribal service area utilized \$35,522.69 in over-the-counter medications and health products. There were 405 Tribal members outside the Tribal service area that utilized \$29,275.65 in over-the-counter medications and health products. This program provides funding for health related items such as vitamins, first aid materials, toothbrushes and cold medications.

Alcohol & Drug Program (A&D)

In 2009, the A&D Program funds were utilized in coordination with other Tribal programs to enhance activities and services that promote accountability to sobriety, financial independence, social well being and community. Specifically, during the year, the A&D program participated in two Tribal health fairs, the "Diamond Lake Family Day," two "Summer Movie" events, the "Fall Dog Show," as well as numerous Diabetes Clinics.

Nesika Health Group

For 2009, there was on average 261 Tribal members enrolled in the Nesika Health Group Insurance Program, with an additional 429 family member dependents. Patient claims for medical services for this group were in excess of \$2 million. More than \$500,000 was paid out for pharmacy, dental and vision services. Tribal members enrolled in Nesika paid between \$50.00 and \$150.00, depending on family size and if they also have Medicare, however, the premium for

the insurance is actually \$550.00 per enrollee. To cover the full premium for the Tribal membership and their families, the Tribal Board has approved an additional \$1,500,000.00 annually for this purpose.

Tribal Distribution

In 2009, Cow Creek Tribal members received a Tribal distribution check in the amount of \$700 from Tribal gaming and business revenue. In December, 904 Tribal members received a total of just under \$630,000. An additional \$410,400 was placed in the Tribal Minor Trust Fund for 562 Tribal members under the age of 18 years. There were also 18 new born Tribal members that were enrolled and received the initial \$1,000.00 deposited into their Tribal Minor Trust Fund for a total of \$18,000.

Tribal Elders Monthly Distribution

The Tribal Elders Monthly Distribution Program paid out \$400.00 monthly to 95 Tribal elders, for an annual total of \$456,000 in 2009. Tribal members become eligible to receive the monthly elder's distribution when they reach the age of 60.

Tribal Burial Benefit

In addition to providing \$3,500.00 towards the cost of funeral expenses for Tribal members, program guidelines for the Tribal Burial Benefit were modified in 2008 to include burial assistance for Tribal spouses. In 2009, six Tribal members passed away. Burial assistance provided by the Tribe totaled \$16,109.74.

All General Council Meetings will be held at 10:00 a.m. at the Cow Creek Tribal Government Offices located at, 2371 N.E. Stephens Street, Roseburg, OR.

The Procedures for the nominations for the Tribal Board of Directors Election are as follows: Any registered voter of the Tribe present at the May meeting each year may nominate. Each person may nominate one individual for the election in August. When nominations are closed, no other nominations will be accepted. A nomination will be considered



complete when the nominee has accepted the nomination in writing. Nomination acceptance forms will be furnished to all candidates represented at the meeting.

For those nominees not present, forms will be mailed to them no later than (3) days following the Nominations Meeting and must be received in the Tribal Government Office no later than June 10 of each year. Candidate acceptance forms will be placed on the ballot in the order the nominations are made. Ballot packets including instructions, will be mailed out to registered voters of the Tribe from the Siletz Agency around July 15th and are due back to the Siletz office by August 6th. Any new voter registration card needs to be completed by May 14, 2010. Tribal members are encouraged to maintain an updated registration card including an updated signature.

It is time to be sure that your 2010 application has been turned in and that your eligibility is current in case you have an accident. Remember ER visits are limited to the Danger of Loss of Life, Limb, Eyesight, or difficulty breathing. Always use Urgent Care otherwise.

If the primary insurance pays at a reduced amount because they deem your ER visit is not an emergency. The patient

then becomes responsible for the portion of the bill that the primary denies. CHS can only pay on the amount the insurance pays on, per federal guidelines.

All visits require a purchase order

All surgeries require approval from the Resource Management Committee - <u>Inpatient and Outpatient</u>
