

## 2011 Outlook

As part of the annual planning process for the Tribe, the Tribal Board of Directors met in January to review important tribal programs and determine how best to implement suggestions and concerns recorded throughout the year. Many issues were discussed and several of the results are listed as follows.

#### **Economic Development Projects**

For the 2011 year, the Board placed priority on the following development projects. Creekside Rest Area – As part of a budget reduction effort by the Oregon Department of Transportation, state officials elected to close two Interstate 5 Rest Areas between Grants Pass and Roseburg. The Rest Area north of Glendale and north of Myrtle Creek were identified to be closed. The Tribe was approached to enter into a public/private partnership with the state to develop a rest area near Canyonville. It was determined that the best location for this Rest Area was on tribal property at exit 99 near the Truck and Travel Center. With grants from both the Department of Transportation and the Bureau of Indian Affairs, the tribe is proceeding with a public/private partnership and development of the Creekside Rest Area. To date, the site work, infrastructure and paving have been completed. Anticipated completion of this project will be this Fall.

#### **Tribal Clinic in Canyonville**

Plans for an additional Tribal health clinic have been finalized and construction of the approximate 12,000 square foot health facility should be underway by fall 2011 with a completion date of late summer of 2012. The facility will be funded with nearly \$2.5 million in IHS Grant funding and clinic revenues from the existing Roseburg Health and Wellness Center and Canyonville Annex Facilities. The new clinic will house a radiology department, expanded laboratory, nine new exam rooms and an additional behavioral health department. Two larger classroom areas will be able to be converted into cooking classes and a small exercise room outside the clinic area. This new facility will provide convenient access to healthcare for south county users, and will help with an overall increased savings for the Nesika Health Group and Contract Health Care.

#### **Rural Business Incubator Center**

As previously reported, the Tribe received a \$2.75 million grant from the USEDA to remodel the Tribes Farmers Co-op Property for use as an Incubator for entrepreneurs with new ideas for business in Douglas County. The incubator center is still under tribal ownership but will collect rent from tenants located within this facility. Several non-profits, Umpqua Training and Employment and UCC Small Business Center have expressed their intent to rent space

within the facility. All of the anchor tenants will be available in one location which will be an added bonus for those seeking business development assistance.

#### **Truck Stop Parking and Shore-power**

Just across Jordan Creek from the Seven Feathers Truck & Travel Center, you will notice a large graveled flat area. Excavation of this area originally began to develop the clay soils into select fill materials for the Creekside dam. As the area developed, it became apparent that additional parking and facilities space created opportunities.

The site is now being developed through a combination of grants and tribal economic development funding into additional truck and RV parking spaces, with several planned enhancements for the future including, a "Shorepower" truck kiosk system to reduce truck idling emissions, an electric vehicle charging station, and a multipurpose truck and RV service center. Paving of the lot is slated for this year, with the additional improvements to be added as funding becomes available.

#### Riverwalk/Amphitheatre

Approval was given by the Tribal Board to move forward with planning a Riverwalk from the Casino north to Stanton Park along with an outdoor venue for entertainment. The idea will be to provide a scenic walkway along the river that would allow guests to make their way toward a proposed Amphitheater or Outdoor stage of some type that will be developed behind the old Valley View Motel. Since completion of the new wing of the Seven Feathers Hotel, occupancy rates have declined in the Valley View Motel which is scheduled to be demolished.

#### Medicare Part B Reimbursement Program Amended

The Tribal Board of Directors have approved an amendment to the Cow Creek Tribal Medicare Part B Reimbursement Program (MPBRP). Currently, this program is designed to reimburse premiums to those Tribal members who are participating in the MPBRP. This reimbursement is available to begin 2<sup>nd</sup> quarter of 2011 (starting in April 2011) and will be reimbursed annually for this first year; reimbursed January 2012 for the April-Dec 2011 premium year. After this first year, new spouse enrollees will have the option to be reimbursed either monthly or continue with the annual reimbursement options.

Tribal Members, who have spouses that are enrolled in Medicare Part B, can now complete an application for reimbursement for their spouse by contacting Andrea Davis, Clinic Benefits Coordinator at 541.672.8533 ext. 5533.

#### **Annual Tribal Distribution and Elders Monthly Distribution Programs**

After more than five years and extensive review, the Tribal Board of Directors have approved an increase to both the Annual Tribal Distribution Program as well as the Elders Distribution Program.

The amount for the Annual Tribal Distribution will increase \$100 bringing the total annual payment to Tribal members to \$800. As with previous requirements, all distributions to minors will be placed in their individual Cow Creek Minor Trust Account.

The Tribal Elders Monthly Distribution Program increase \$50.00 bringing the total monthly distribution to \$450.00.

Approval of these changes have been made to the Tribal Distribution Code by the Tribal Board of Directors, however additional approval must be obtained by the US Secretary of the Interior which is expected to be achieved by the fall of 2011.

## **Cow Creek Tribal Gardens Project**

The Tribal Board of Directors has authorized development of a Tribal Gardens Project on the Tribe's Ravenswood Ranch Riverside property (see below). The Project will be surrounded by a low tree screen and deer fence, and is anticipated to include a small greenhouse, fruit and nut orchard, berry rows, and raised vegetable plots, all under central irrigation. Fencing and planting on the project will begin in 2011, to be completed with programs beginning in 2012.

Fruit, nut and berry species anticipated to be grown at the facility include: Raspberry, Huckleberry, Strawberry, Marionberry, Boy-



senberry and Loganberry; Braeburn, Gala and Jonagold apples; Bing and Royal Ann cherry; Red Haven, Elberta and Suncrest peach; Bartlett pear; Blue Black Italian, Blue Damson, Blue Black and Shiro plum; Filbert, English Walnut and Chestnut trees.

The Tribal Board intends for the gardens to be a Tribal family gathering place as well as an agricultural and educational asset for Tribal benefit. However, the final scope of programs at the facility will not be determined until tree planting and infrastructure construction is substantially complete later this year.



## NESIKA PARTNERS WITH FIRST CHOICE HEALTH AS NEW PROVIDER NETWORK

As many of you may be aware, Nesika has made numerous changes for the 2011 plan year. One of those changes was to partner with First Choice Health who we will be utilizing for our provider network as of January 1, 2011.

The First Choice Health network extends to the following states: Alaska, Washington, Oregon, Idaho and Montana. If you live in one of those states you can either contact a Nesika Health Group representative to help you find a contracted provider or you can go online to FCHN.com and search for a provider there as well. If you live in any other state your claims will be processed utilizing the Usual & Customary fees for your particular area meaning that you no longer have to find a contracted provider. Please remember that as always you must first meet your yearly deductible and the claim must be for a covered service and diagnosis in order for the services to be covered under the plan.

## **Diabetes Prevention Class Recruitment**

The Cow Creek Tribes Diabetes Prevention Team is looking for volunteers to participate in our Diabetes Prevention Program (DPP).

#### What is the DPP?

The Diabetes Prevention Program is based on the findings of a national study that diabetes is preventable in those at high risk. The focus of the program is on making lifestyle changes to try to prevent diabetes.

#### What is Pre-Diabetes?

Pre-diabetes is a condition where blood sugar levels are higher than normal but are not high enough to be called diabetes.

#### Who can Join?

American Indian men and women age 18 or older who are eligible for services at CCHWC and who have pre-diabetes.

#### What will I be Asked to do?

- Become more physically active and learn healthier eating habits.
- Attend 16 classes, one class per week, to explore ways to live a healthier life.
- Work with a Lifestyle Specialist over the next three years to lose weight, get more active and be healthier!

The program is tuition-free, camping gear is provided, and we work with any students living outside of the Seattle area to ensure that travel is not an issue. More details are in the attached application.



## **Beaver Conference -2nd Year Success**

The Cow Creek Band of Umpqua Tribe of Indians was one of many sponsors for the State of the Beaver 2011 Conference on February 2- 4 at the Seven Feathers Convention Center and Resort in Canyonville, Oregon. Other sponsors included the Beaver Advocacy Committee, South Umpqua Rural Community Partnership (SURCP) and the Partnership for the Umpqua Rivers (PUR) in collaboration with State and Federal agencies along with academic and private institutions.

This event focused on the latest developments in beaver ecology related to habitat restoration, climate change mitigation, the beaver wetlands influence on wildlife and had several breakout sessions the last day to discuss next steps. Nearly 100 people attended each day. High school and college students were a highlight of the attendees on Thursday.



Donald Hey Ph.D., Executive Director of Wetlands Research Inc. from Chicago was the keynote speaker. Beavers are a keystone species, whose dam building activities create connectivity between land and water, greatly enhancing both aquatic and terrestrial ecosystems. They are the original ecological engineers. Oregon's salmon runs are intimately connected to beaver populations. The connection between beavers, water quantity and quality is well established. Beavers have a direct positive effect on aquifers, water temperature and water availability. Due to historic over-

hunting and current conflicts with human development, the Oregon's beaver populations are not even close to what they once were. The Tribe is currently working with SURCP, PUR and the Umpqua National Forest on Beaver relocation efforts in the Elk Creek Watershed.

## **Food Program**



The Cow Creek Food Program is available to Cow Creek Tribal families in need. The program is open on the **second Tuesday from 9-12 pm** and the **fourth Tuesday from 1-4 pm** each month at the tribal office in Roseburg. Applications will not be mailed, however, upon arriving you will be able to complete your form and receive assistance. This program is qualified by "income self-certification" and tribal enrollment with no service area requirements. No other member of extended family will be able to pick up food nor will it be delivered by a staff member except under extenuating circumstances. ## **Project Warmth**

Project Warmth is a reimbursement program for shoes and coats for kids. Youth between the ages of newborn through 16 who are tribally enrolled may qualify for assistance. No income guidelines or service area requirements are necessary. Each child may access this program once per year.
