

MEDFORD CASINO THREATENS SEVEN FEATHERS

Surprising headlines last week regarding the purchase of land in Jackson County by our coastal neighbor, the Coquille Indian Tribe have caused grave concerns to Cow Creek Tribal leaders. Media reports indicate that the Coquille Tribe intends to enter the "land into trust" process on property they acquired in Medford and operate a Class II Casino. These reports were confirmed in a private meeting between Cow Creek Umpqua and Coquille Tribal leadership last Friday, September 7, 2012.

Growing population, health and social needs and additional job opportunities for Coquille tribal members were cited by the Coquille's as justification for their egregious actions and flagrant disregard for the Cow Creek Umpqua Tribe.

The purchase of land in Jackson County by the Coquilles is a direct assault on Cow Creek and Seven Feathers. Jackson County is an extremely important market for the Seven Feathers Casino Resort and represents a significant percentage of the Tribe's revenue used to fund tribal economic development, health, education, and housing programs. Should they be successful in operating a casino in Medford, Cow Creek revenues will be severely diminished.

Cow Creek Umpqua is the primary tribe for Jackson County. Not only do we have a strong modern day presence throughout the area, we have


extensive documentation that supports our aboriginal claim to the Rogue and Bear Creek Valley's. The Coquilles have no historical tie to the Medford area which is nearly 175 miles from their home base in Coos Bay, Oregon.

We have expressed to Coquille leadership, in no uncertain terms, that Cow Creek will <u>aggressively</u> fight <u>any</u> attempt by their Tribe to place land into trust in Jackson County or to operTHE BILLION FOODS

ate any gaming facility that will threaten the wellbeing of the Cow Creek Umpqua Tribe.

Tribal Officials are working with the Oregon Political Delegation as well as representatives from the Department of Interior to immobilize Coquilles efforts.

Tribal Housing Programs Get a New Look



The Tribe is proud of the growth and development within the Tribal Housing program. You will notice that the name has changed and there is a new logo.

The Tribal Housing Program will now be referred to as Wilīⁱ Housing. You can pronounce it as (We-leee), it is the word for Housing in our traditional Takelma language. With the growth of our low to moderate income housing and development of new programs, the Tribe felt it was time to adopt a formal name for the program. There are now housing units available for Tribal members to rent in Tri-City, Myrtle Creek and Winchester. Additional areas for housing units are being looked at near larger area employers, schools, hospitals and public transportation routes.

The Wilīⁱ Housing Program is still accepting applications for the Tribes Low to Moderate Income Rental homes. This program is federally funded through the Housing and Urban Development (HUD), Indian Housing Block Grant and is administered by the Tribe.

This program can assist eligible tribal members who are currently living or are willing to relocate to the seven county service area with Low to Moderate Income rental units. Priority is given to families with the greatest needs in relation to income, family size, age, disabilities, etc.

Contract Health News

September is here and your, 2013 CHS applications will be arriving in the mail, one for each family member. If you live in the seven county service area (Coos, Deschutes, Klamath, Jackson, Josephine, Douglas and Lane) it is a requirement that you fill out an application every year for each member to be eligible for CHS benefits by 1/1/2013. If CHS has not received your application by 01/01/2013 you will not be able to get a purchase order number until your application has been received.

Things to know about Cow Creek Contract Health Services:

- It is important to read Contract Health News monthly so you know if there has been any change to the program.
- It is the patient's responsibility to call for Purchase orders 2-3 days in advance.
- If it is a new facility or doctor call 7 days in advance so CHS can get them set up in the system. Have the facility name and their phone number available.
- If you go to the doctor be sure to remind them that you have Cow Creek Contract Health as a payor of last resort.
 Payor of last resort means Insurances, State Medicaid, and Medicare always pay first.

If you receive a statement, call the vendor and be sure they have billed Cow Creek Contract Health Services. If you send us the statement a lot of the time the vendors will not talk to us because of HIPPA laws and it makes it very hard for CHS to get the needed paperwork to cover your out of pocket expenses.

The number one reason for Denials is, no Prior Authorization. Always call for a purchase order and remember a purchase order is date sensitive and if the date changes or you have to go back, it requires a new purchase order.

IHBG Down Payment Assistance



This is a new program that is administered through the Wilīⁱ Housing Program and is funded with IHBG HUD funding. This program has just been approved by the Tribal Board of Directors and can assist income eligible Tribal Members with additional funding when purchasing a home. This program is limited to the Seven County Service Area and is designed to assist Cow Creek Tribal Members with down payment and or closing cost towards the purchase of a home. The maximum amount of money available for each tribal member through this program is \$5,000.00. To be eligible Tribal Members are required to attend a financial competency class prior to applying for the program. The candidates will be screened and assessed for the need prior to any award of funding is distributed. There is a limited amount of funding for this program on an annual basis and Tribal Members will be assisted on a first come first serve basis. This grant can also be used in conjunction with the existing Down Payment Program that is offered by the Tribal Board of Directors.

Tribal Housing

The Cow Creek Housing Program is still accepting applications for the Tribes Low Income Rental homes. This program is federally funded through the Housing and Urban Development (HUD), Indian Housing Block Grant and is administered by the Tribe.

This program can assist eligible tribal members who are currently living or are willing to relocate to the seven county service area with low-income rental units. Priority is given to families with the greatest needs in relation to income, family size, age, disabilities, etc.

Reminder

If you are currently on the waiting list for a house please make sure that your address and phone number are up to date. If your name is coming up on the list and we cannot get ahold of you, we will be forced to pass you by until we hear from you. Also remember that if you are on the waiting list your application needs to be updated on an annual basis.

Nesika News

There are some services that are performed for the Nesika Health Group members that needs to be prior authorized before the services are performed in order to avoid a possible penalty.

The services that need to be prior authorized are:

Hospital Admission- prior to any Hospital admission which is not a Medical Emergency, the covered person's attending Physician must (or the Covered Person may) contact the Utilization Management Organization for authorization. In the case of Urgent or emergency admissions, the Utilization Management Organization must be contacted within 72 hours after admission.

Home Health Care- prior to beginning a program of home health care

Hospice Care – prior to beginning a hospice program

Outpatient Surgical procedures – prior to any elective (i.e., non-emergency) surgery that is performed on an outpatient basis.

MRI, CT and PET Scans-prior to having the MRI, CT or PET Scan, unless it is after hours and the scan is done on an emergent basis.

If the preauthorization requirements are not completed, the Plan's normal benefit percentage will instead be "50%". This reduced percentage will apply to <u>all</u> services and supplies that are provided to the member and that are related to the confinement or procedure.

Nesika will not reduce or deny a claim for failure to obtain a prior approval under circumstances that would make obtaining such prior approval impossible or where application of the prior approval process could seriously jeopardize the life or health of the patient. (e.g., the patient is unconscious and is in need of immediate care at the time medical treatment is required.) However, again remember that you, your physician, or the facility can call to Innovative Care Management within 72 hours of the incident to obtain the prior approval/authorization.

Prior authorization is not a guarantee of coverage. The utilization Management Program is designed only to determine whether or not a proposed setting and course of treatment is medically necessary and appropriate. Benefits under the Plan will depend upon the person's eligibility for coverage and the Plan's limitations and exclusions.

Nesika Health Group is contracted with Innovative Care Management to provide a Utilization Management Program. The phone number for ICM is 800-862-3338. This number can also be found on the back of your Nesika Health Group medical card.

If you do not have a current card or have lost or misplaced your card, please contact the Nesika office at 800-284-9917 to order a replacement card.



Medicare Part B Reimbursement

If at any time during the 2012 calendar year <u>Medicare Part B</u> premiums were withheld from you or your spouse's Social Security benefit, you may qualify for reimbursement from the Tribe. Tribal members aged 65 or those receiving disability payments are eligible for Medicare Part B insurance.

At the end of each calendar year, the Social Security Administration (SSA) sends recipients a <u>SSA-1099</u> form for tax purposes that details social security benefits. According to the Social Security Administration the <u>SSA-1099 forms for year 2012</u>, will be mailed to recipients by the last week of January 2013. In order to expedite annual premium reimbursement, please mail a <u>copy</u> of the <u>SSA-1099</u>. For your *monthly reimbursement* a <u>detailed Statement letter</u> which is also sent from SSA by January 2013 is required. Checks will be distributed upon receipt at the beginning of the New Year. Please write how you would like your reimbursement either monthly or annually. Members with a spouse please make sure you include the spouses name and a copy of your marriage certificate (if you haven't sent it already) to request an **SSA-1099** or **Statement letter**. Please contact your local Social Security Administration office by dialing 1-800-772-1213.

If Medicare Part B premiums were paid for you through a retirement account, pension fund, or by some other means, you may still be eligible for reimbursement. Please provide proof in which payment was made.

Please be aware if you have been receiving your monthly premium reimbursement from the tribe you must turn in the New Year's 2013 statement letter in order for your payments to continue uninterrupted. Tribe a Cooperating Agency to BLM's New Land Management Planning Process

The Cow Creek Band of Umpqua (Tribe) has signed a Memorandum of Understanding (MOU) with the Bureau of Land Management (BLM) to participate as a Cooperating Agency in the new Resource Management Planning process for western Oregon BLM lands. Cooperating Agency status is only awarded to governments or entities that have legal jurisdiction over the lands included in the planning process. The last time the Tribe participated as a cooperating agency was during the designation process of the Huckleberry Patch Special Interest Area on forest service lands. Natural Resources Director, Amy Amoroso, will represent the Tribe on the committee and provide feedback and review documents in association with this new lands planning process. The entire process is expected to take 3 years and will result in a new management plan for western Oregon BLM lands and an Environmental Impact Statement for the management objectives.

Tribe Urges "Vote No on Oregon Measures 82 and 83"



It's a BAD deal.

When it comes to opening a privately owned casino in Portland, history seems to be repeating itself.

A Foreign owned casino conglomerate is funding a campaign to convince Oregon voters to pass Measures 82 and 83 and authorize Oregon's first private casino at the deserted dog track at Wood Village. This substantially funded initiative, advertised as the "The Grange" is being promoted as a family entertainment center complete with shopping malls, restaurants, waterslides and a farmers market that will supposedly bring thousands of jobs to Portland and millions of dollars to Oregon.

But what is cleverly missing, or is buried in a sea of fantastic photos and other exciting amenities, is any prominent mention of a casino. As you may recall, Oregon voters handily defeated a similar measure in 2010 by a 2 to 1 margin. That measure was clearly advertised as a private casino.

The current "Grange" advertisements are distributed throughout Oregon and include a barrage of television commercials in dozens of markets, a slick foldout brochure to registered voters, community meetings throughout Oregon and an attractive website that also solicits vendors and suppliers.

This may sound good, but it is bad for Oregon! Oregon will lose millions of dollars. The majority owners of this venture are Canadian and the profits will be funneled out of Oregon.

Currently, for every dollar of revenue from Video Lottery Terminals, about 65 cents goes to the State Lottery. Under measure 82, for every dollar produced by "The Grange Casino" and other private casinos, only 25 cents would go to the State Lottery. It's important to understand that the top 50 Lottery outlets generating the most profits are located within a 5 mile radius of the proposed Grange Casino, which will destroy these businesses.

Oregon Citizens' Initiative Review Panel

In 2011, the Oregon Legislature approved a bill creating the Citizens' Initiative Review panel. Each election, a group of citizens are selected by using a random sampling procedure that reflects Oregon's demographics as a whole. The purpose of this panel is to evaluate ballot measures so voters have easy access to clear, useful, and trustworthy information at election time. This year the panel met for 5 days on Measures 82 and 83 and heard testimony from proponents, lottery officials and law enforcement.

The Citizens Initiative Review panel overwhelmingly voted against these two measures by a vote of 17 to 7. Their opinion statements will be placed in the Oregon Voters Pamphlet.

The following is a list of their findings:

- Measure 82 changes the Oregon constitution. If this measures passes it will allow more outside influence on gambling within the state. The backers who wrote this measure stand to gain significant profits by changing the Oregon constitution.
- Changing the Oregon state constitution, with no clear economic benefit to Oregonians, is not worth the possible negative effects to our citizens.
- Measure 82 will negatively impact the revenue generated by tribal casinos traditionally used to support tribal communities, nearby rural areas, non-profits and charitable organizations throughout Oregon.

• Small businesses near private casinos could stand to lose up to 46% of Video Lottery Terminal revenue on average. We believe this loss would have a substantial impact on businesses.

income tax. Lottery officials believe people who might otherwise spend their money on video poker would gamble instead at the proposed casino, which backers have dubbed "The Grange." They say the state would end up a loser.

Another important piece of information is that Tribal Casinos must have compacts with the state of Oregon and must fund 100% of state regulatory costs, such as background investigations on key employees and vendors. There is no provision for private casinos to have to pay for regulatory costs, that burden will fall on the taxpayers.

Over the Counter Self Pay

For self-pay reimbursement, please include the following to prevent payment delay:

- Name(s) of tribal member(s), phone number and mailing address
- Legible receipts showing the date
- If highlighting, use yellow only; it is better to bullet an item rather than highlight it
- Separate OTC items from regular grocery items i.e., subtotal or obtain separate receipt
- Self-pay reimbursement receipts may be submitted at any time for the current year. The cut-off date does not apply. However, receipts must be received by December 31st of the current year. When faxing or emailing, please call the program coordinator, Tamara Robinson, at 541.839.1347 to confirm the information was received.


