

State of the Beaver Conference



A major event is coming to the Seven Feathers Casino and Resort this month. The State of the Beaver Conference will be held at the Convention Center from January 23rd to the 25th. This conference has been hosted for several years by our Tribe, and has featured a number of experts in the field of beaver conservation from around the world. We are expecting a large turnout this year, and are very excited to be hosting such an important event. The issue of beaver conservation isn't given as much attention as it deserves, and having a major international conference right in Canyonville, at our very own Seven Feathers Conference Center, is a wondrous thing!

The Beaver Conference is an annual event, and started with the Beaver Advocacy Committee, a local group that supports expanding the vital role of beavers within local ecosystems and beyond. One may wonder, what do beavers do in nature? Some people unfairly categorize beavers as a nuisance species, without properly understanding the beneficial aspects of these animals. Of course, most people know beavers for dam construction. But what do dams do in the environment? Why are beavers so important?

Beavers are the second highest species, after humans, in terms of altering their environment. A beaver dam reroutes water flow, increasing the source in some places, and reducing it in others. This allows certain plant species locally to thrive more. It also creates

Natural Resources Conservation Service Convenes Local Working Group to Discuss Natural Resource Priorities

Roseburg, Ore. (January 14, 2013) — Since the Dust Bowl, the *'Soil Conservation Service'* has worked with local communities to determine resource concerns and to target technical and financial assistance available through the Farm Bill. Now known as the Natural Resources Conservation Service, we consider basic resource concerns affecting soil, water, air, energy, plants, animals and humans. We work in partnership with interested community members to prioritize natural resource concerns and identify those conservation activities of greatest interest to landowners. Our programs are voluntary and are therefore most successful when we target support for issues identified by local people.

Farmers, ranchers, forest landowners, and other agricultural and conservation organizations are invited to participate in our annual meeting to review resource priorities February 7, 2013 at the Conference Room of the Oregon Department of Fish and Wildlife on Diamond Lake Highway in Roseburg at 10 am. more wetlands, which are important to coho salmon, salmonid, and other aquatic species. Just like any other species, beavers are an important part of the local ecosystem, and removing them without fully understanding the consequences of such actions can be detrimental to both the local plant and aquatic species.

If beavers are causing flooding or other problems within the Usual and Accustomed Area, you can contact the Beaver Advocacy Committee at beavers@surcp.org; outside of that area, please contact your local wildlife office. However, you should be aware that an issue with moving beavers to a new habitat is that their digestive systems aren't as resilient as ours. The digestive bacteria in a beaver's stomach gets used to a certain type of plant, and if there aren't the same plant species in another location, then the beaver cannot digest the food that they eat. In some cases, a beaver literally starves to death with a full stomach because they have not had the time to adjust to their new food source.


The best plan is to not relocate beavers at all, but if it is necessary, move them to an area where some of their foods are present, to allow them time to adapt to their new environment.

We all greatly anticipate a successful conference this year, and a great turnout. So far, we have a large number of attendees from various backgrounds and areas of research. SOPTV To Air "Standing Strong" Video



The "Standing Strong, the Tribal Nations of Western Oregon" video will be shown on Southern Oregon Public television Saturday, February 24, 2013 at 8:00 PM.

The video is distinctively unique in describing the termination era of the mid 1950's experienced by the Confederated Tribes of Siletz, the Confederated Tribes of Grand Ronde, the Coquille Tribe, the Coos, Lower Umpqua and Siuslaw Tribes and the Cow Creek Band of Umpqua Tribe of Indians. Each tribe provided their own historical material and featured speakers.

There is a general information portion at both the beginning and end of the video that emphasizes the importance of recognizing tribal sovereignty and the governmental status of recognized Indian tribes.



PRESCRIPTION MEDICATIONS

Just a little pharmacy awareness for those members that are on Nesika Health Group.

Nesika Health Group uses Restat for their Pharmacy Benefits Management. If you are on Nesika and do not have a pharmacy card that states Restat on it, please contact the Nesika office, so that one can be obtained for you. You must have this card in order to access your pharmacy benefits.

Your co-pay will be \$10.00 for a generic medication; \$20.00 for a formulary brand-name medication; \$40.00 for a non-formulary brand-name medication; and the lesser of 20% or up to \$150 for specialty medications. If you have questions about what your co-pay would be, please contact Restat's help desk at 1-800-248-1062 or the Nesika office.

You must use a participating pharmacy. If you go to a non-participating pharmacy, you will not be reimbursed for any portion of the cost of the medication. The only pharmacy charges that we will consider reimbursing, is if you are prescribed a compounded medication. A lot of the pharmacies that do the compounding, will not bill the insurance. The member must pay for the prescription in full. The member must then submit all of the paperwork that is provided with this compounded medication directly to the Nesika Office. If the medication is covered, then the member would receive a direct reimbursement from Restat. The co-pay for compounded medication is \$40.00.

If the medication is one that requires a prior authorization from Restat, then a prior authorization must be in place before the medication is obtained. If the member pays for the full amount of the medication and then submits a receipt for reimbursement, there will be no reimbursement until the time that it has been approved and the pharmacy reruns the billing through the system.

As always, if you have a medication that you can obtain at one of the pharmacies for a lesser co-pay (\$4.00 to \$10.00), you will save yourself part of the co-pay.

Contract Health News

Let the New Year begin. Have you turned in your 2013 application? You are <u>not</u> eligible for Contract Health Services until they receive your current CHS Application for 2013.

- ♦ Call 2 3 days in advance for purchase orders.
- If it is a Holiday or the office is closed, call the next business day for a purchase order.
- Purchase orders are date sensitive and are required for EACH date of service, even if it is a continuation from the prior visit.
- ◆ The number one reason for denials is no prior authorization. (NO PO#)
- All surgeries require prior authorization from the resource committee.
- ♦ It is the member's responsibility to call in no purchase orders will be given to facilities.
- ♦ If the member is eighteen years old, a call from mom or grandma will not be accepted. (it is the adult member's responsibility)
- If you are going to a new facility call five to seven days in advance, have the name and phone number so you can give it to CHS.
- ♦ The bill could be the member's responsibility if wrong information is accepted from someone other than CHS. Always call if there is any question about rules or procedures.
- ♦ The eye benefit is every 2 years.
- ♦ When a statement is received, read to see if Cow Creek Contract Health Services has paid, if not, call and make the vendor aware that CHS needs to be billed. Don't assume they know especially lab or radiology.

Be sure to read Contract Health News for changes and reminders. Call CHS at 541-672-8533 X 1 if anything is unclear.

Registration is only required once, however it is the members responsibility to keep an updated address on file with the Tribal Government Office. If you have been married or divorced and have changed your name a new registration needs to be turned in as well.

Tribal Identification Cards are available to all Tribal members upon request. To obtain an I.D. card, contact Janet at the Cow Creek Government Office at 541-677-5575 or 800-929-8229. You will be sent an application to fill out and sign. You will be required to enclose a photo and mail the completed application back to the Government Office for processing. Properly filled out applications will be processed with the Tribal Chairman's signature and will be mailed back to you. Tribal I.D. cards are legal documents and are accepted as legal proof of identity.
