

## **Hunting News**

Reminder!! To all Tribal members who hunted this year with an Oregon State tag. Report big game and turkey tags by Jan. 31, 2015

Don't forget to report your hunt results no later than Jan. 31, 2015 for most 2014 hunts. Report online or by phone (1-866-947-6339).

Hunters need to complete a report for each deer, elk, cougar, bear, turkey and pronghorn tag purchased (or picked up as part of a Sports Pac)—even if they didn't hunt or weren't successful.

Deer and elk hunters who don't report must pay a \$25 fine to get a 2016 hunting license



# **Nice-N-Soft Sugar Cookies**

## **Ingredients:**

- · 1 cup butter, softened
- · 1-1/2 cups confectioners' sugar
- 1 egg
- · 1-1/2 teaspoons vanilla extract
- · 2-1/2 cups self-rising flour

## **Frosting:**

- 2-1/2 cups confectioners' sugar
- · 1/4 cup water
- · 4 teaspoons meringue powder
- · 1/4 cup light corn syrup
  - Green, red and yellow food coloring

#### **Directions**

1.In a large bowl, cream butter and confectioners' sugar until light and fluffy. Beat in egg and vanilla. Gradually add flour. Divide dough in half. Cover and refrigerate for 2 hours or until easy to handle.

2. On a lightly floured surface, roll out one portion of dough to 3/16-in. thickness. Cut with floured cookie cutters. Place 2 in. apart on ungreased baking sheets.

- 3. Bake at 375° for 5-7 minutes or until set. Cool for 2 minutes before removing from pans to wire racks to cool completely. Repeat with remaining dough.
- 4. For frosting, in a small bowl, beat the confectioners' sugar, water and meringue powder on low speed just until combined. Beat on high for 4 minutes or until soft peaks form. Add corn syrup; beat 1 minute longer.
- 5. Tint with food coloring of your choice. Cover frosting with damp paper towels or plastic wrap between uses. Spread and/or pipe frosting on cookies. Let stand until set. Yield: 3-1/2 dozen.

# Christmas Break Time!! Think about Youth Hunter Safety Course....



Is your youth planning on applying for a Tribal Hunt or Oregon State tag next year? Christmas break is a great time for your youth to take the online hunter safety course. To sign up, log on to the Oregon Fish and Wildlife official website which is www.dfw.state.or.us click on the "Youth Education" tab under "Hunting" to get started. The course takes about 4-6 hours and can be done at their own pace. Once they have completed the course, print the certificate and schedule an upcoming field day through the ODFW website. All youth hunters are required to have their hunter safety card prior to hunting; The Tribe can provide computer access and funding for this course at the newly opened Cow Creek Education and Workforce Center located in Tri City. ## **Purchased/Referred Care News/Deadlines**

Wow a New Year is upon us and PRC/CHS would like to thank everyone for making this a great year and we are looking forward to assisting you with your medical and dental needs in the coming year.

2015 Applications are due by 01/01/2015 to be eligible for care. No purchase orders will be issued until PRC/CHS has received your 2015 application in the office.

We are unable to process any purchase orders for 2015 until 01/02/2015 as the system has to be updated the morning of 01/02/2015 to allow purchase orders for 2015 to be issued.

If you receive a statement and it should be paid by PRC/CHS please call the vendor and make them aware that they need to bill PRC/CHS. Most offices will not talk to us without written consent.

Remember to use Hometown and tell them you are a Cow Creek member as this saves PRC/CHS a huge amount of money allowing PRC/CHS to have the ability to provide more services for tribal members in the seven counties. You need to be referred from the Cow Creek Health and Wellness Clinic or using the Clinic for care to be eligible for the benefits.

All surgeries, MRI's and expensive scans require prior authorization from the RMC before the date of service. It requires chart notes, medical need and cost so it can be determined if it is needed and if the funds are available.

## **Medicare Part B Reimbursements**

If at any time during the 2014 calendar year <u>Medicare Part B</u> premiums were withheld from you or your spouse's Social Security benefit, you may qualify for reimbursement from the Tribe. A Tribal Member aged 65 or those receiving disability payments and paying for Medicare Part B insurance.

At the end of each calendar year, the Social Security Administration (SSA) sends recipients a <u>SSA-1099</u> form for tax purposes that details social security benefits. According to the Social Security Administration the <u>SSA-1099 forms for year 2014</u>, will be mailed to recipients by the last week of January 2015. The 1099 form is used for annual reimbursements, you will also receive a **statement letter** which is what one needs for monthly reimbursement payments. We do not need your original. Please send a copy or ask the front desk to make a copy for you. Please place the Tribal member name on the document as we don't always know who the tribal spouse is. Reimbursement checks will be distributed upon receipt at the beginning of the New Year. Please write how you would like your reimbursement either monthly or annually. A copy of your marriage certificate is also needed (**if you haven't sent it already**). You can also access this information by going online to **mymedicare.gov**.

If Medicare Part B premiums were paid by you through a retirement account, pension fund, or by some other means, you may still be eligible for reimbursement. Please provide proof in which payment was made.

## **LIHEAP Program**

**Energy Assistance**- We will be starting a new digital intake application process for this program. Tribal members with low income, who need assistance to pay an energy bill, please call Cindy Delay 541-677-5575 to schedule a 15 minute intake appointment. We will be eliminating paper applications.

Required documents to bring with you:

- Most recent utility bill
- 3 months proof of income from each household members
- Photo Identification for all Household Members
- SS cards for all Household Members (unless already on file)
- Written Statement of explanation (if the utility bill is not in your name) and an official piece of mail in your name with same address that is on your utility bill
- If 0 income write a statement of how you make ends meet







## **Expanding Horizons Youth Center**



The Education and Workforce Center (aka Expanding Horizons Youth Center) is open. The Center is open for **adults** Tuesday-Thursday 10:00-2:00 and by appointment Monday and Friday. # TDaP Immunization

Pertussis (whooping cough) is a highly contagious respiratory disease that has seen a resurgence in the last 2 years. Oregon has seen a 3 fold increase in the number of pertussis cases. This disease can cause serious illness in infants, children and adults. It starts like a common cold, with runny nose or congestion, sneezing and maybe mild cough or fever. Severe uncontrollable coughing can begin after 1-2 weeks. This cough can be so severe that it forces all the air from the lungs and patients are forced to inhale with a loud "whooping" sound. The coughing can last for weeks or months. Pertussis is worst for babies with many infants requiring hospitalization. Many infants who get whooping cough are infected by parents, older siblings, grandparents, or other caregivers who might not even know they have the disease. The best prevention is to get vaccinated and to keep infants away from anyone who has cold symptoms, is coughing, or who has NOT been vaccinated.

If you are unsure if you have had your TDaP vaccination, please visit us – either north or south clinic – and get your immunization up to date!
