

The United States Supreme Court Rules for Tribal Sovereign Immunity

Bay Mills Indian Community, the US Supreme Court upheld the doctrine of tribal sovereign immunity for off reservation tribal commer-

The case involved an off reservation casino that the tribe built in an urban area over 100 miles from the Bay Mills community, but never opened or operated.

Michigan sued the tribe and tribal officials for a gambling operation in violation of the Indian Gaming Regulatory Act (IGRA). The Bay Mills tribe defended on the basis of existing tribal sovereign immunity law, which can shield official tribal action and personnel from non-tribal jurisdiction, even off of tribal lands, for official actions including business.

The Supreme Court ruled that the IGRA only applies to gaming on tribal lands and that the casino in question was not on tribal lands and, therefore, there could be no IGRA violation. The Court also ruled that the tribe and its officials were immune from suit for their official actions in the case, absent action by the US Congress.

Importantly, however, the Court also noted that the casino in question, as well as its operators and patrons, could be sued or subject to criminal liability for operating illegal off reservation gambling. It remains to be seen whether the Bay Mills Tribe will try an open the casino and we assume there will be criminal arrests made and roads blocked if they do, and that Tribal sovereign immunity will not apply.

On May 27th, 2014, in the case of Michigan v. Some commentators seem to believe that this ruling will lead to a tribal casino in every corner. And there probably will be a few pirate gambling operations that try to push the limits based on this ruling and it is possible that some of them will avoid enforcement; but not in Oregon. Unless the BIA approves the proposed Coquille Medford casino (which is unlikely in the very short term), tribal gambling expansion will likely remain limited to pre-IGRA tribal lands, such as at Warm Springs and Confederated Coos.

> The Bay Mills decision can be considered a victory for Indian Country because it preserves tribal sovereign immunity at current levels. The decision could also be a wolf in sheep's clothing, however, since the facts - off reservation otherwise criminal activity - made the Bay Mills tribe look like rogue casino operators relying on a technicality to avoid liability; and that is the type of case tribal detractors are looking for to try to convince congress to limit tribal sovereignty.




Culture Camp 2014 - A Great Big Success



Student Rental Assistance Open Enrollment 2014-2015 School Year

The Student Rental Assistance Program will be accepting application beginning July, 2014 for the upcoming school year. This program is designed to assist low to moderate income level Tribal Members who are attending school full time at an accredited college, university, or technical school with a monthly rental stipend. Applications must be filled out in their entirety and all requested documentation must be provided to be considered for this program. Applicants that do not provide all required documents will not be considered. This program is funded with federal grant money and applicants need to meet low income guidelines for eligibility. Applicants cannot pay more than 30% of their annual income and must have a signed landlord information sheet to be eligible.

Please contact Sarah Briggs Resident Manager to request an application to apply for the program. Applications are also available online for download at www.cowcreek.com. If you are a continuing student an application must be resubmitted and all requirements need to be met prior to receiving continued assistance. Funding is limited for this program therefore applications must be received in a timely manner to be reviewed. Contract Health News/ Hometown Drugs Information



For those members who don't know where Hometown Drugs of Roseburg Inc. is located, a map that starts at the Tribal offices and goes to Hometown Drugs on Harvard has been included.

Start at Cow Creek Government Office (A)

1. Turn left from parking lot onto NE Stephens St toward Clover Ave 0.6 mi
2. Turn right onto NE Stewart Pkwy 0.2 mi

3 continue on Stewart Parkway past McDonald's in 1.3 mi 3.1 mi

Turn left onto W Harvard Ave 0.2 mi after passing Stewart Park and Legion Field 1813 W. Harvard Ste. 210 (Hometown Drug) will be on the right (B)

Please call with your information to get set up in advance when you plan to begin using this pharmacy. Hometown's phone number is 541-229-1112.

Enrolled Cow Creek members and affiliated Tribal members need to make their tribal affiliation known because a different billing is used for those patients. Non-tribal members using the clinic can utilize Hometown's services but there will be a co-pay.

All patients of the Cow Creek Health and Wellness Center can have their Rx sent to the clinic or mailed to their home address. Also the option of getting a ninety day supply is available at Hometown Drugs.

Please note: As a payor of last resort CHS can only pay after the primary Insurance has paid and CHS does not quote other carriers benefits.

For customer convenience there is a drive up window on the west side of the building. With vacations in full swing and the beginning of the new school year coming soon, please remember to schedule your children's sport physicals. The North Clinic in Roseburg or the South Clinic in Canyonville are now scheduling for July and August appointments.

New Pharmacy Benefit Cards

Beginning on July 1, 2014 Nesika Health Group has a new pharmacy benefits manager, Kroger Prescription Plans in Portland, OR.

You can use most retail pharmacies to fill a 30 day supply of your medications. To locate your nearest participating pharmacy, you can go to the website KPP.com, click on pharmacy locator, put in your ID number and a zip code. The locator will list the nearest participating pharmacies. You can also call 1-800-575-7712 for assistance.

Kroger Prescription Plans offers a new feature Mail Order at Retail. With this option you can obtain a 90-day supply of maintenance medication at your local Fred Meyer Pharmacy or take advantage of the home delivery through Postal Prescription Services (PPS). PPS is located in Portland, OR and can be reached at www.ppsrx.com or 800-552-6694. Orders are accepted 24 hours a day, 7 days a week. PPS hours of operation are Monday through Friday 6AM to 6PM, Pacific Time, Saturday 9AM to 2PM, Pacific Time. The mailing address for PPS is PO BOX 2718, Portland, OR 97202.

In addition, all Kroger owned pharmacies can fill for a 90 day supply locally (Fred Meyer, Ralph's, QFC, or Food4Less). Hometown Pharmacy in Roseburg can also fill for the 90 day supply. All other retail pharmacies can only fill for a 30 day or less supply.

Hot day recipe - Shrimp Ceviche

Shrimp is marinated in lime juice to cook, then mixed with tomato, cilantro, onion and a special sauce. You can save a couple of whole shrimps to dangle on the edge of the tumbler for a special presentation. The lime and the cilantro are the key, and of course fresh shrimp.

Ingredients:

2 pounds large shrimp - peeled, deveined and chopped

3/4 cup fresh lime juice

5 roma (plum) tomatoes, diced

1 white onion, chopped

1/2 cup chopped fresh cilantro

1 tablespoon Worcestershire sauce

1 tablespoon ketchup
1 teaspoon hot pepper sauce
salt and pepper to taste

1 avocado - peeled, pitted and diced 16 saltine crackers or tortilla chips

Directions:

1.Place the shrimp and lime juice into a large bowl, and stir to coat. Let stand for about 15 minutes, or until shrimp are opaque. The lime juice will cook them. Mix in the tomatoes, onion, and cilantro until coated with lime juice; cover and refrigerate for 1 hour

2.Remove from the refrigerator, and mix in the Worcestershire sauce, ketchup, hot sauce, salt and pepper. We have our own hot sauce recipe, but you can use whatever hot sauce you like, or leave it out and let people add their own when serving.

3. Serve in glass tumblers and top with avocado pieces. Set out extra Worcestershire sauce, ketchup (or cocktail sauce) lime wedges and hot sauce for people to individualize their dish. Serve with saltine crackers or corn tortilla shells/chips
