



Tribal Chairman Resigns

Long time Cow Creek Tribal Chairman, Sue Shaffer, announced her resignation at the Sunday, May 16, 2010 meeting of the Tribal General Council. Shaffer gave a brief statement about her years of service to the Tribe before taking a seat in the audience with the general council. Upon her resignation, long time vice-chairman, Dan Courtney, resumed the meeting and will remain as acting chairman until the August 10 election meeting where at that time the Tribal Board Members will seat new officers for the 2010-2011 year.

Courtney, who recently retired from the Veterans Hospital in Roseburg,, was elected to the Tribal Board of Directors in 1991 and has served as Vice-Chairman since 2001.

"We look forward to continuing with stable and sound policies that have been established by the Tribal Board over the past many tears," Courtney said. "As always, our Tribal board is dedicated to


PACT/Dewberry Lawsuit Defeated-Again (Continued pg 2)

After a tortured procedural history, opponents of the Confederated Coos, Lower Umpqua and Siuslaw Indians' (CTCLUSI) Three Rivers Casino finally had their trial day in court - and lost. The lawsuit began in 2003 when the group "People Against a Casino Town" (PACT) attempted to stop the CTCLUSI from using tribal trust lands near Florence, Oregon, as

(PACT) attempted to stop the CTCLUSI from using tribal trust lands near Florence, Oregon, as a casino site.

Through the years, the case boiled down to the question of whether or not the Governor of Oregon has the authority to enter into gaming compacts with Tribes pursuant to the federal Indian Gaming Regulatory Act since there is a "no casino" clause in the Oregon constitution.

As a result, the case has had the potential to impact all Oregon tribes with gaming operations, not just the CTCLUSI. Oregon tribes, including Cow Creek, signed on to legal positions in the case supporting the CTCLUSI and the right of the Oregon Governor to compact with the tribes under federal law.

On May 3, 2010, Oregon Circuit Judge Karsten Rasmussen agreed with the Tribes and the Oregon Governor, holding:

"Under the Indian Gaming Regulatory Act, Governor Kulongoski and the Confederated Tribes entered into a valid gaming compact, which lawfully permits the Confederated Tribes to operate the Three Rivers Casino & Hotel on restored lands. The Governor had the constitutional and statutory authority to bind the State of Oregon to the terms of the Compact. In short, the no casino prohibition of the Oregon Constitution is preempted by federal law on Indian lands."

PACT attorneys have promised to appeal the case "all the way to the U.S. Supreme Court" but, for now, their case is defeated and their chances of a reversal in their favor are slim.

We will keep watching.

UIDC Job opening and employment application information

With the application now on line, Tribal members can apply for job openings from their home computer. For the first five days that a job is posted only Tribal member applications will reviewed by hiring managers. After five days, if there are no qualified Tribal member applications the position will be open to the general public. All General Council Meetings will be held at 10:00 a.m. at the Cow Creek Tribal Government Offices located at, 2371 N.E. Stephens Street, Roseburg, OR.

The Procedures for the nominations for the Tribal Board of Directors Election are as follows: Any registered voter of the Tribe present at the May meeting each year may nominate. Each person may nominate one individual for the election in August. When nominations are closed, no other nominations will be accepted. A nomination will be considered




complete when the nominee has accepted the nomination in writing. Nomination acceptance forms will be furnished to all candidates represented at the meeting.

For those nominees not present, forms will be mailed to them no later than (3) days following the Nominations Meeting and must be received in the Tribal Government Office no later than June 10 of each year. Candidate acceptance forms will be placed on the ballot in the order the nominations are made. Ballot packets including instructions, will be mailed out to registered voters of the Tribe from the Siletz Agency around July 15th and are due back to the Siletz office by August 6th. Any new voter registration card needs to be completed by May 14, 2010. Tribal members are encouraged to maintain an updated registration card including an updated signature.

If you are a registered voter and do not receive a ballot, you must contact the Government Office at 541-672-9405 or 800-929-8229.

Tribal Emergency Food Program By Rhonda Malone





Education News: JOM Program Services

What is JOM or Johnson O'Malley?

The Johnson O'Malley (JOM) Program is a supplemental education program that provides services to the Cow Creek Tribal members from Pre-School to the 12th grade. Tribal members that live outside of the 7-county service are eligible for parental costs and tutoring services. Students must be attending a school in order to receive services. JOM consists of a 7 member parent committee that meets the first Monday of each month. The JOM Parent Committee plans the yearly activities for students in the 7-county Tribal service area every year. The JOM Parent Committee also approves tutoring requests for students in the 7-county service area.

How do I utilize JOM services?

Even though JOM is planned by the JOM Parent Committee, in order to receive services you need to contact the Education Director. All new applicants need to fill out a JOM Application. For every request for services such as Parental Costs or Tutoring a "Request for Services" is required to be filled out. Any changes in address, phone number or school, please notify the Education Director to update your student's file.

What are Parental Costs?

Parental Costs is a \$100.00 per year allowance for JOM students. The 100.00 per year follows the calendar year of January through December. Parental Costs cover any school fees, sports fees, pre-school fees, music fees, dance fees, etc. To verify if a fee will be covered contact the Education Director.

Each year JOM students are eligible for \$25.00 per student for school supplies. The \$25.00 per year follows the calendar year of January through December.

Higher Education Deadline is fast approaching:

The Higher Education deadline for fall is August 1st. For students that want to be funded for the 2010-2011 academic year this is the deadline to send in the completed application. Education forms can be downloaded from the Cow Creek Tribal website www.cowcreek.com or contact the Education Director.

Oregon Archaeology Celebration Exhibit Comes to Seven Feathers

Oregon Archaeology Celebration (OAC) is Oregon's archaeology month that is held every October with activities all over the state. Since 1994 the OAC committee has designed a unique poster every year for the celebration that features an aspect of Oregon archaeology, and provides information about how to get a calendar of events.

In 2008 the OAC committee created an exhibit called "OREGON ARCHAEOLOGY CELEBRATIONS: INVITATIONS TO THE PAST" to bring attention to archaeology in Oregon. The exhibit features the annual posters and describes their themes, such as preservation of shipwrecks and shell middens, technologies through time, archaeological evidence of climate change, volunteers in archaeology, Fort Rock Cave, the Oregon Trail, and Champoeg. A new poster is



added every year. The exhibits goals are to show that Oregon has a rich archaeological past worth supporting and protecting, and that the public is invited to activities celebrating Oregon archaeology every October.

So far the exhibit has been seen at the Columbia River Maritime Museum in Astoria, the High Desert Museum in Bend, the Newberg Library, Tamastslikt Cultural Institute in Pendleton, and OMSI in Portland. During April-May it will be at the Washington County Museum, and then move to the Cow Creek Band of Umpqua Tribe of Indians "Seven Feathers" Casino in Canyon-ville this June through September.
