Cow Creek Historical Markers To Be Dedicated July 28

Two historical markers on Cow Creek history will be the first markers on tribal history to be dedicated on I-5. The dedications of these beautiful panels titled, "Cow Creeks: A Land of Strong Recovery" and "Homeland of the Cow Creeks," will take place on Saturday, July 28.

Dr. Stephen Dow Beckham, Ph.D. and ethno-historian/author, will speak about the significance of these markers in the homeland of the Cow Creek Tribe at the two dedications, one occurring at 10 a.m. at the Í-5 southbound South Umpqua Rest Area, south of Roseburg, and the other at 11:15 a.m. at the northbound Cow Creek Rest Area, north of Glendale. The dedications are hosted by the Cow Creek Band of Umpqua Indians and the Oregon Travel Information Council. After the ceremonv. the Cow Creek Band will host a reception at Seven Feathers Convention Center. Cow Creeks: A Tale of Strong Recovery

The story of the Cow Creek Band of Umpqua Tribe of Indians is a tale of perseverance and strong recovery in the face of great loss. Epidemics and hostilities with miners led to large population declines. The tribe entered into a treaty with the United States in 1853, and ceded nearly 800 square miles for less than three cents and acre. This treaty left them without access to traditional hunting and gathering areas or a land base to build upon.

Despite a treaty with the U.S. Government — one of Oregon's first clearly defining boundaries of their homelands, a federal program of Indian removal attempted to forcibly remove the Cow Creeks to reservations in northwest Oregon. Many members eluded capture by hiding in remote parts of the region — seven core families maintained a continuous presence in the area. The U.S. Government ceased pursuing them by the 1870s, and tribal families began gradually returning.

The 1853 treaty provided for various services that the U.S. Government disregarded for nearly 130-years.

The Cow Creeks sued the United States for restoration of federal recognition in 1982, and a monetary setttlement of \$1.25 per acre for lands ceded (1855 prices) was awarded in 1984. The tribe placed the entire settlement in an endowment account using interest earnings for economic development and tribal programs. In 1992, the Cow Creeks began a substantial economic development program in Canyonville with economic self-sufficiency as their goal.

Homeland of the Cow Creeks

This portion of southwest Oregon is homeland to the Cow Creek Band of Umpqua Indians. They thrived here for thousands of years before contact with Euro-Americans. Living in plank-house villages, they followed a seasonal round of resource use. Moving from summer camas meadows and salmon fisheries along the rivers to the high country, they picked huckleberries and hunted for deer in the fall. By late fall they returned to the valleys to collect acorns and preparé for winter.

A rapid influx of miners and settlers after the discovery of gold in 1851 forever changed the Cow Creek world. Critical food sources declined and the newcomers brought infectious diseases - Chief Miwaleta was among the casualties. Within a few years the tribe was reduced to starvation. The loss of land and resources led to violent confrontations throughout the region.

Despite a treaty with the U.S. Government — one of Oregon's first clearly defining boundaries of their homelands, a federal program of Indian removal attempted to forcibly remove the Cow Creeks to reservations in northwest Oregon. Many members eluded capture by hiding in remote parts of the region — seven core families maintained a continuous presence in the area. The U.S. Government ceased pursuing them by the 1870s, and tribal families began gradually returning.

Make Sure Your Child's Health is Ready for School!

Physicals for Tribal children are available at the Cow Creek Health and Wellness Center at no charge. Services available include:

- Well child physicals for infants and pre-school age children including developmental, speech, vision, and hearing evaluations as appropriate.
- Pre-entry physicals for kindergarten students including speech, hearing, and vision evaluations.
- School, camp, and sports physicals for older tribal children.

Immunizations are available for Tribal children at the Cow Creek Health and Wellness Center at no charge. New immunization requirements for school year 2001/02 are:

- e Children in daycare need hepatitis B series vaccine as well as a varicella (chicken pox) vaccine or the child must have had the chicken pox disease
- Kindergarten children must have the varicella vaccine or have had the chicken pox disease
- Kindergarten, first grade, and second grade children must have a hepatitis B series vaccine and a

second dose of the measles, mumps, and rubella vaccine (MMR).

■ Seventh grade children need a hepatitis B series vaccine as well as a second dose of the measles, mumps, and rubella vaccine (MMR), as well as a second dose of the varicella vaccine. If a child has had the chicken pox disease, they do not need the varicella vaccine.

First Alert Announces Recall on Fire Extinguishers

First Alert Company, manufacturer of fire extinguishers, has announced a recall on some of their model number FE1A10G extinguishers. The model number is located on the extinguisher's label along with the serial number. If you have a First Alert fire extinguisher, check the model number. If you own the FE1A10G model, you must then check the serial number. Serial numbers that start with the following combinations of two letters: RH, RK, RL, RP, RU, OR RW indicate extinguishers that are

being recalled. Please call the First Alert Company at 1.866.669.2736 for a refundable coupon.

It's important to have a fire extinguisher that works in your home. Most fires double in size every second. Once a house fire begins, you usually have less than five minutes to vacate your entire famiy. It's important to have a plan of evacuation, to practice that plan, and to have a predetermined place to meet in order to make sure everyone is out of the house safely.

Medimpact Prescription Cards

Recently, Tribal members eligible for contract health received I.D. cards to be used to have prescriptions filled. These cards DO NOT replace any primary insurance you might have. Please continue to use your primary insurance when you need prescriptions filled, and contract health will pay your co-pays.

BIA Housing Improvement Program

The BIA's Housing Improvement -Program (HIP) is accepting applications for housing assistance. HIP is a Bureau of Indian of Affairs (BIA) federally funded program contracted and administered by the Tribe. The program can assist eligible Tribal members living within the seven county service area with housing needs such as repairs, rehabilitation (roof repairs, weatherization, window installations, door installations, structural repairs, electrical needs, plumbing repairs, etc.) or replacement housing. Priority is given to families with the greatest need as determined by income, family size, age, and other factors.

Fill out the application, sign the I.D. card, enclose an appropriately sized photo, and mail the material back to the Tribal Government Offices for processing.

PLEASE DON'T FILE IN ANYTHING ON THE I.D. CARD EXCEPT YOUR SIGNATURE.

Properly filled out applications and signed I.D. cards will be processed with the Tribal Chairman's signature, laminated, and mailed back to you.
