

Staying Stress Free At Work*

The working world is filled with requirements and deadlines that create stress. Life is filled with stress. Everyone experiences it. Here are a few suggestions to help any person calm down and achieve productivity, i.e. manage stress.

• Stay focused. Finish one project before moving on to the next.

• Relax. Slow, deep breathing can relax a person within minutes.

Stressed people have shallow breathing.

• Ask for help. When you're feeling overwhelmed, say so.

• Avoid confrontation. If a person is upset, wait for a calm moment to discuss a delicate issue. Stress can boil over into unnecessary confrontation.

Cow Creek Contract Health Guidelines

There have been some misunderstandings regarding the guidelines for Cow Creek Contract Health. To assist those who have questions, the guidelines are listed below:

ELIGIBILITY – In order to qualify for contract health care, you must:

- 1. Be an enrolled member of the Cow Creek Band of Umpqua Tribe of Indians.
- 2. Reside in Douglas, Jackson, Josephine, Lane, Deschutes, Coos, or Klamath County.
- 3. Pre-authorize all non-emergent services. Emergencies MUST be called in to the Cow Creek Tribal Health Office (toll free number is 1.800.935.2649) within 72 hours of service.
- 4. Use all alternate resources, such as OMAP, Medicare, and/or private insurance. CHS pays as a last resort.

PRE-AUTHORIZATION – All services provided must be pre-authorized by calling the Tribal health office toll free number at 1.800.935.2649 or the local number, 672.8533. When calling, make sure you can provide the following information:

- 1. The name and address of the medical provider,
- 2. The date of the appointment,
- 3. The medical problem you are being seen for, and
- 4. Any support services that may be required, such as x-rays, blood work, etc. At the time of approval, you

will be given a number/s for your appointment/s. Please write this number down and refer to it when you're making inquiries about billing. REMEMBER, if the date of the appointment changes, you must call the Tribal health office and let them know of the date change or your bill may not be paid.

IF YOU ARE SEEN AT AN URGENT CARE FACILITY OVER A WEEK-END, PLEASE CALL THE TRIBAL HEALTH OFFICE ON MONDAY MORNING.

DENIAL – Reasons for denial include:

- 1. Ineligible for Contract Health,
- 2. Failure to obtain pre-authorization for non-emergency services,
- 3. Failure to obtain approval for an emergency service within 72 hours of having been seen,
- 4. Failure to use alternate resources, and
- 5. The service for which you requested payment by CHS is not within medical priority.

APPEALS – If a person is denied payment for care, the Health Director issues a denial letter. The letter of denial states the reasons for the denial and explains the rights of appeal. The person has 30 days from receipt of the certified letter to appeal in writing to the Tribal CEO for reconsideration. The letter must contain additional information not previously submitted. If the CEO upholds the appeal, an additional appeal may be made to the Tribal Board of Directors who will make the final determination.

Housing Assistance

BIA Housing Improvement Program (HIP)

The Housing Improvement program (HIP) is accepting applications for housing assistance. The HIP program is a Bureau of Indians Affairs (BIA) federally ided program contracted and administered by the Tribe. This program can assist eligible Tribal members living with-in the seven county service area with housing needs such as: repairs, rehabilitation (roof, weatherization, windows, doors, structural repairs, electrical, plumbing, etc.) or replacement housing. Priority is given to families with the greatest need in relation to income, family size, age, disabilities, etc.

Tribal Housing Program

The Tribal Housing Program can assist Tribal members with down payment assistance or home repair assistance. This program is not restricted to the seven county service area, however, applicants must be ineligible for the BIA HIP program.

Indian Health Service Sanitation Assistance

The Indian Health Service Sanitation Program can assist tribal members living within the seven county service area with sanitation needs such as: installation of septic systems, installation of wells, pressure systems, and hook-ups to community services.

The Foundation Board of Directors established The Buss Rondeau Award in 1000 to honor the memory of Buster Rondeau, a Tribal board member and founding member of the Cow Creek Umpqua Indian Foundation.

"Support for literacy and youth education was very dear to Buster's heart," according to Sue Shaffer, Tribal Chairman. "Buster felt that strengthening the family and providing opportunity for education were the keys to personal success." Buster Rondeau was raised in the Tiller area. The Cow Creek Umpqua Indian Foundation was created in 1998 to meet the philanthropy requirements of the State and Tribal Compact.

Tribal Child Care Program Has Two Openings

The Cow Creek Tribal Child Care Program is federally funded and serves enrolled Cow Creek Tribal youth who live within the seven county service area of Lane, Douglas, Josephine, Jackson, Klamath, Deschutes, and Coos Counties. Parents must qualify by income and must also be working, enrolled in school, or attending a work experience program. Children cared for by the Tribal Child Care program must be under age 13.

The Child Care Program operates as a certificate program. This means that parents who qualify are responsible for screening and selecting who they want to provide child care for their children. A Tribal representative inspects and qualifies or disqualifies the chosen home/provider as a Tribal child care home. The Tribe does not operate a day care center.

A nomination will be considered complete when the nominee has accepted the nomination in writing. Nomination acceptance forms will be furnished to all candidates represented at the meeting. For those nominees not present, forms will be mailed to them no later than three (3) days following the Nominations Meeting and must be received in the Tribal office no later than June 10 of each year. Candidate acceptance forms will be placed on the ballot in the order the nominations are made. Ballot packets, including instructions, will be mailed out to registered voters of the Tribe from the Siletz Agency no later than July 19, 2003. Tribal members are encouraged to maintain an updated registration card including updated signature.

If you are a registered voter and do not receive a ballot, you must contact the Tribal Government Office at 1.800.929.8229 or 1.541.672.9405.

Elders Program For 2003 Announced In February

Tribal members are encouraged to maintain a current address at the Tribal Government Offices. Tribal members with minor children who are not living in their household also should make sure their children's updated addresses are on file with the Tribal Government Offices.

Tribal Identification Cards are available to all Tribal members upon request. To obtain an I.D. card, contact Carol Ferguson at the Cow Creek Government Offices at 1.800.929.8229. You will be sent an application with an I.D. card. Fill out the application, sign the I.D. card, enclose an appropriately sized photo, and mail the material back to the Tribal Government Offices for processing.

PLEASE DON'T FILL IN ANYTHING ON THE I.D. CARD EXCEPT YOUR SIGNATURE.

Properly filled out applications and signed I.D. cards will be processed with the Tribal Chairman's signature, laminated, and mailed back to you.
