Cow Creek Contract Health Guidelines

There have been some misunderstandings regarding the guidelines for Cow Creek Contract Health. To assist those who have questions, the guidelines are listed below:

ELIGIBILITY – In order to qualify for contract health care, you must:

- 1. Be an enrolled member of the Cow Creek Band of Umpqua Tribe of Indians. Newborns have 90 days to become enrolled.
- 2. Reside in Douglas, Jackson, Josephine, Lane, Deschutes, Coos, or Klamath County.
- 3. Pre-authorize all non-emergent services. Emergencies MUST be called in to the Cow Creek Tribal Health Office (toll free number is 1.800.935.2649) within 72 hours of service.
- 4. Use all alternate resources, such as OMAP, Medicare, and/or private insurance. CHS pays as a last resort.

PRE-AUTHORIZATION - All services provided must be pre-authorized by calling the Tribal health office toll free number at 1.800.935.2649 or the local number, 672.8533. When calling, make sure you can provide the following information:

- 1. The name and address of the medical provider,
- 2. The date of the appointment,
- 3. The medical problem you are being seen for, and
- 4. Any support services that may be required, such as x-rays, blood work, etc. At the time of approval,

you will be given a number/s for your appointment/s. Please write this number down and refer to it when you're making inquiries about billing. REMEMBER, if the date of the appointment changes, you must call the Tribal health office and let them know of the date change or your bill may not be paid.

IF YOU ARE SEEN AT AN URGENT CARE FACILITY OVER A WEEK-END, PLEASE CALL THE TRIBAL HEALTH OFFICE ON MONDAY MORNING.

DENIAL – Reasons for denial include:

- 1. Ineligible for Contract Health,
- 2. Failure to obtain pre-authorization for non-emergency services,
- 3. Failure to obtain approval for an emergency service within 72 hours of having been seen,
- 4. Failure to use alternate resources, and
- 5. The service for which you requested payment by CHS is not within medical priority.

APPEALS - If a person is denied payment for care, the Health Director issues a denial letter. The letter of denial states the reasons for the denial and explains the rights of appeal. The person has 30 days from receipt of the certified letter to appeal in writing to the Tribal CEO for reconsideration. The letter must contain additional information not previously submitted. If the CEO upholds the appeal, an additional appeal may be made to the Tribal Board of Directors who will make the final determination.

Mandatory Health Coverage Guidelines

The Oregon Health Plan is available to persons who have low to moderate income and are uninsured or underinsured. If you live within the seven county service area, Federal guidelines for the Tribal Contract Health Plan require that "...all alternate resources be exhausted prior to payment by Contract Health." Failure to comply with this regulation could mean the loss of the Tribal Contract Health Program. Therefore, it is necessary that Tribal members who reside within the seven county service area and who are eligible for Oregon Health Plan apply for coverage.

Should you receive an application for the Oregon Health Plan, either from the Tribal Health office or the Oregon Medical Assistance Program (OMAP) office in Salem, you are required to fill it out and return it within 30 days of the date stamped on the envelope. If

you would like assistance filling out this form, please call the Tribal Health office at 1.541.672.8533 or 1.800.935.2649 to set up an appointment.

If your application is not received at OMAP within the given time frame, or your application is denied because you failed to respond with the additional information in a timely manner, your Tribal Contract Health benefits will be suspended until you comply. If you think you're ineligible for OMAP because your income is too high and you don't want to have to fill out an application, you may submit your previous three months' pay stubs or proof of income for review. COW CREEK HIGHER EDUCATION PROGRAM GUIDELINES

Students who intend to access Cow Creek grant monies for assistance with their higher education are reminded they must:

- 1. Be enrolled for twelve or more credits for the current term
- 2. Maintain a minimum of a 2.0 GPA
- 3. To access Cow Creek grant monies, each student must send grades from the previous term as well as their schedule for the upcoming term to Cow Creek Education Director Kelly Strickler at the Cow Creek Government Office

DIRECTIONS TO BARE RANCH PARK:

From the north, take exit 113 off I-5, the Clarks Branch Road exit. Turn right at the stop sign. At the next stop sign, take a left. You will now be on Dole Road. Follow the road behind the small market/motel until the K-Bar Ranch sign, at 5719 Dole Road, is visible. Turn right. Go over the railroad tracks. This road will lead you right to Bare Ranch Park. The South Umpqua River will be on your left as you drive this dirt road.

From the south, take the Clarks Branch Road, exit 113, off I-5. Turn left at the stop sign and left again at the next stop sign. Those two lefts put a person on Dole Road. Once on Dole Road, follow the directions detailed above.
