Construction for Phase II of the Cow Creek Government Offices began in October of 2004 and is scheduled for completion in late spring or summer of 2005. Currently, the Government Offices, as well as those in the Clinic, are at capacity.

The New facility will be located adjacent to the south side of the existing building in the south parking lot.

"The completion of the additional offices," Sherri Shaffer, Tribal CEO said, "will allow us to expand our services and programs to the Tribal membership and community."

The new building will include 20 new offices and meeting rooms, as well as viewing areas for tribal artifacts and displays.

## Nesika Health Group - Open Enrollment

The annual open enrollment for the Nesika Health Group begins December 1, 2004 through December 20, 2004.

Cow Creek Tribal members who are interested in enrolling their spouse, or dependents or are interested in reenrolling, will be eligible during this open enrollment time.

All required enrollment information must be returned to the Nesika office no later than December 20, 2004. Once approved, the

insurance coverage will be effective on January 1, 2005.

# Cow Creek Health & Wellness Center Awarded \$2.2 Million Grant

In June, 2004, Tribal Health Director, Dr. Sharon Stanphill, initiated the formation of a consortium with the Coquille Indian Tribe and the Klamath Tribes to prepare a grant proposal in the area of Diabetes Prevention. Over 260 grant proposals nationwide, were submitted to the Department of Health and Human Services, Indian Health Service, for which only 30 grants were to be awarded. The grants require rigorous data collection, establishing baseline measures, implementing an intensive intervention with patients who are at risk for developing diabetes and measuring this success (prevention of diabetes) over a four-year period. In late September, 2004, the tribes were notified they had received one of the thirty prevention grants and would be receiving \$2.2 million over the next five years, to be split amongst the tribes to implement the project. Dr. Grimm, Director of Indian Health Services, visited Portland on October 7, 2004, and presented the tribes with the oversized checks and congratulating all Portland Area recipients on their successful procurement of funds.

The grant is a result of a 1997 congressional appropriation for \$30 million per year to the Indian Health Service's Special Diabetes Program for Indians (IHS) (SDPI) for the prevention and treatment of diabetes in American Indians and Alaskan Natives. This grant has resulted in over 300 diabetes prevention and treatment programs in Indian communities nationwide. In 2003, Congress increased the SDPI funding to \$150 million per year, and directed HIS to use a portion of the increase in funding for a "competitive grant program" to fund grantees to implement programs which will 1) directly prevent diabetes and 2) cardiovascular disease risk reduction.

The four-year project phase will begin

at the end of 2005 and will provide patients at risk for developing diabetes, the opportunity to work closely with numerous staff members in order to lose weight, begin and maintain an exercise program, participate in intensive behavior change education sessions and adopt coping and behavioral skills necessary to maintain such behavior changes.

These key components of lifestyle changes will be offered as tribal members dedicate themselves to improve their health and work with the staff in preventing this chronic disease. Knowing diabetes is not inevitable, this program is a landmark attempt by Congress to provide funding to aid tribes in identifying "best practices and lessons learned" which can be shown effective and can then be used for all tribes nationwide in their communities to also prevent diabetes. While this project is

not scheduled to begin until later in 2005, tribal members are encouraged to take advantage of the current diabetes prevention activities offered at the Wellness Center, such as weight management and cooking classes, exercise instruction and tobacco cessation to name a few.

Other Pacific Northwest Indian tribes that were funded include the Confederated Tribes of Warm Springs, the Tribal Consortium of Chehalis, Skokomish, Shoalwater Bay, Squaxin Island, and Nisqually, Quinault, Couer d' Alene, and Colville. They were all funded for the prevention of diabetes. The Seattle Indian Health Board, Yakama and the Tribal Consortium of Swinomish, Nooksack and Upper Skagit Tribes were funded for cardiovascular disease risk reduction.

# Over-The-Counter Program

Each year the Cow Creek Overthe-Counter (OTC) Program provides Cow Creek tribal members \$100 towards approved nonprescription medications, medical supplies and preventative products.

Requests for items under the 2004 OTC Program concluded November 15, 2004. The only exception, however, is for Sonicare toothbrushes which are \$50 each and can be deducted from the remaining balances. Replacement heads for the Sonicare toothbrushes are also available.

Requests for next years' OTC Program can be made after January 3, 2004. "As the new program year approaches", said Tamara

Robinson, OTC Program Coordinator, "Tribal members are reminded that there may be a 24 hour processing time for each request of four items or more, depending upon the volume of requests." Requests will need to be made in advance and will not be accepted if made fromthe store or pharmacy. Faxed and

emailed requests will be gladly accepted.

### Medicare Prescription Drug Benefits

Tribal members that are eligible for Medicare Part A or B are also eligible to receive the Medicare Prescription Drug Benefit card. This Prescription Drug Benefit card should reduce medication prescription costs, even with other prescription drug benefits. Once qualified, an additional \$600.00 benefit may also be available.

The Cow Creek Health & Wellness Center has completed their




series of the 2004 3rd Annual Health Fairs. The
