FAFSA Application Deadline

The FAFSA is a federal financial aid to college students who qualify (based on income). After January 1, 2005 college students may file for 2005-2006

FAFSA (Free Applications for Federal Student Aid). If a 2005-2006 FAFSA application is not submitted by February 1, 2005, it will not be considered as a pri-

Tribal Dental Health Program

The Tribal Dental Program offers Cow Creek tribal members living within the seven county service area a \$1,500.00 allowance for needed dental treatment within the time period of October, 1, 2004 through De-

cember 31, 2005.

The only requirements are that the tribal member must reside within the seven county service area and must call in for each appointment prior to the visit (for a preauthorization

/ purchase order number).

Since October, 58 Cow Creek tribal members have received benefits from the Dental Program totaling \$17,959.00. The staff at the Health & Wellness Center looks forward to continue serving Cow Creek tribal members in the Dental Health Program. Steelhead Restoration Project

The Cow Creek Steelhead Restoration Project is designed to adapt young steelhead from state ran hatcheries to the waters of the South Umpqua River. Steelheads are a much larger version of rainbow trout, born in fresh water. They hold in rivers and streams for 12 to 18 months before migrating to the ocean to feed and wander for a year or two, after which they return back to rivers and streams for spawning.

Volunteers are needed to net fish in the transportation tanks and move them into the acclimation ponds. The release process includes data collection and netting fish inside the tanks. All ages are welcome to participate. Those who have already inquired about the project will be contacted with the project dates.

The Steelhead Restoration Project dates are:

ment Offices for processing.

Properly filled out applications will be processed with the Tribal Chairman's signature and mailed back to you.
