Please stop by and say hello! The Cow Creek Health and Wellness Center (CCH&WC) is expanding access for patients in Canyonville. CCH&WC, through the

Umpqua Indian
Utility Cooperative (UIUC), is
renovating a
facility located
at 270 Gazley
Bridge Road,
Canyonville,
which is across
the street from
Burger King near

the Seven Feathers Resort
Casino. This facility is being
renovated into a 4 exam
room health center with a
laboratory, reception and
waiting areas. CCH&WC will
provide most of the same
health services that are currently provided at the Roseburg clinic. Cooperation with
the different tribal departments, combined with the
excellent work by the UIUC

esort has being made this provith a ject a and success.

The CCH&WC – South clinic is due to be open in early November.

September 26<sup>th</sup> tribal youth and their immediate families gathered at the Tribal Government offices to journey north to participate in the Youth Outdoor Recreation ropes course event in

We gathered for a breakfast snack at 7:15 followed by a blessing led by Justin Mathison.

After a 2.5 hour van ride we arrived at Youth With a Mission (YWAM). Following a brief introduction by our facilitator Ron we jumped into our first activ-

Following each activity we gathered in a circle to de-brief each exercise and identify the skills being taught.

Our first activity demonstrated trust, team building and the "power of support". The second activity proved to be bit more challenging, but after several attempts the group began to display great communication, leadership and organizational skills.

It was then time to get off the ground. The third activity split us into two groups the Tigers and the Lions. We were instructed to complete a circular medium height obstacle course. The difficult part was that we needed to start at the same point and proceed in opposite directions towards each other. We were not allowed to touch the ground or we would have to restart that section.

Cow Creek Tribal Youth proved to excel, finishing the course in record time while continuing to display team work, communication skills, community unity skills, and support through positive encouragement.

Our forth mission was to step way outside of our comfort zones. We journeyed to a large Douglas fir tree with a 2X4 platform approximately 47 feet up. After some encouraging words from our facilitator we watched as Jay set the bar high in bravery. We watched while Jay was safely harnessed to a cable by

can only issue checks in the Tribal member's name that matches the name which appears on your social security card . This is the name we must list on the form 1099 per IRS requirements..

## New Tribal Government Administration Named

At the September 13, 2009 Tribal Board of Directors Meeting, tribal members Michael Rondeau and Lonnie Rainville were appointed to new positions within the Cow Creek Tribal Government. Rondeau was appointed as the new Tribal Administrator (CEO) for the Cow Creek Tribal Government, While Rainville was hired to replace Rondeau as the Tribe's Chief Operations Officer.

Rondeau, while attending college in 1986, began working for the Tribe as the Housing Improvement Program Coordinator and went on to head up other tribal programs such as education, planning, and contract and grants management. Rondeau has also been very politically active in state and national tribal affairs and has been involved in lobbying activities for the Tribe at all levels.

In addition to his extensive work for

the Tribe, Rondeau has a background in local community organizations and is a current board member of the Mercy Foundation, the Umpqua Economic Development Partnership and the Douglas County Regional Investment Board. He is also a current member of the Coalition for Good Government. His past board member experience includes the Roseburg Area Chamber of Commerce (2 terms), the Consumer Credit Counseling Service of Douglas County, the **Douglas County March Dimes (Past** President), and the Douglas County Historic Review Committee.

Rainville began his career with the Tribe as the Benefits Coordinator at Seven Feathers Resort in 1996, after graduating from Western Oregon University with a Bachelors of Science Degree in business Administration. After four years working for the casino, Rainville took a three year stint

at Mercy Hospital as the Human Resource Generalist/Project Manager. In 2003, he returned to Seven Feathers Resort and was quickly elevated to the Director of Human Resources for all of the Umpqua Indian Development Corporations businesses.

Rainville also has broad experience in community affairs, and currently sits on the boards for the Boys and Girls Club, Umpqua Partners Drug Free Coalition and the South Umpqua Schools Foundation. Rainville also is on the advisory board for a UCC South Douglas County Education Center, and has been the South Umpqua Schools Budget Committee Chair for the past two years.

Both gentlemen are graduates of Project Leadership, a community networking and volunteer training program sponsored by the Roseburg Area Chamber of Commerce.

gram again on January 4, 2010.

## Emergency Room Services through Nesika Health Group

When a member goes to the emergency room for a medical emergency such as acute onset of chest pain, abdominal pain, or an injury/accident, Nesika Health Group will cover the services after appropriate deductible, and assuming that a contracted facility is used at 80% of the contracted rate. Also, if you are traveling and have need of medical services, and the emergency room is the only facility that you can locate, this would be covered at the 80% of contracted or U & C charges, depending upon whether the facility was in



our network or out-of network. Should you access the emergency room for **non-emergent** services such as a cough, cold, conjunctivitis (eye infection), or ingrown toenail, then

these services will be reduced by 50% of the allowed amount and then covered after deductible at 80% of the contracted rate.

It is suggested that if you are suffering from one of these non-emergent ailments that you call your family physician or go to one of the local urgent care facilities for treatment.

## **Housing Assistance Programs**

#### **Tribal Low Income Rental Housing**

The Cow Creek Housing Program is continuing to accept applications for the Low Income Rental homes located in Tri-City, Oregon. This program is federally funded through the Housing and Urban Development (HUD), Indian Housing Block Grant and is administered by the Tribe. This program can assist eligible tribal members whom are currently living or are willing to relocate to the seven county service area with low-income rental units. Priority is given to families with the greatest needs in relation to income, family size, age, disabilities, etc. In an ongoing effort to promote a smoke free environment and reduce the risk of second hand smoke, these homes have been designated as smoke-free homes.



# Tribal Down Payment or Housing Repair Assistance Program

The Tribal Down Payment or Housing Repair Program can assist tribal members with a down-payment or home repair s. This program is not restricted to the seven county service area.

#### **Tribal Rental Assistance Program**

The Tribal Rental Assistance Program

is a new program approved by the Cow Creek Band of Umpqua Tribe of Indians Board of Directors. This program was established to assist Tribal members living in Non HUD operated, Tribal Housing (the homes owned privately by the Tribe) with monthly rental payments. Tribal Members would be responsible for paying 20% of their annual income towards their rental payment and the HUD program will be available to subsidize the remainder of the rent.

#### **Student Rental Assistance Program**

The Student Rental Assistance Program is a new program approved by the Cow Creek Band of Umpqua Tribe of Indians Board of Directors. This program will assist Tribal Members who are attending school full time at an accredited college, university, or technical school with a monthly rental stipend.

## Status of Cow Creek Businesses

Over the last couple of weeks, there has been significant interest in the status of the business operations owned and operated by the tribe. Interests range from Tribal business revenues and investments to issues with the Tribal insurance program, the Clinic and healthcare providers and personnel matters. These items and others were the topics of discussion at a tribal gathering on September 20, 2009 at the Tribal Government Office.

Issues regarding the financial condition of the casino, Tribe and tribal businesses were discussed and are currently being reviewed by the Tribal Board of Directors. Concerns

involving employee headcount, reductions in workforce and input from Tribal Government on casino management decisions at the resort were discussed. There will be further information on these topics provided to the General Council once an audit is completed.

A concern about Nesika Health Group's coverage of emergent/nonemergent visits to hospital emergency rooms during weekends and evenings was expressed. For more information on this topic, please see "Emergency Room Services through Nesika" article on page 5 of this newsletter.

A concern about tribal clinic providers not having "Hospital Privileges"

was also discussed. For more information about this topic please see "CCH&W Questions and Answers" article on page 7.

Another concern discussed was the treatment of tribal member employees in tribal businesses and career opportunities and advancement. This topic is currently being reviewed by both the UIDC Board of Directors and Human Resource Department. ## CCH&W QUESTIONS AND ANSWERS

# Q: Why Don't Our Providers Have Hospital Privileges?

A: Our scope of healthcare coverage at the Cow Creek Health & Wellness Center is to serve tribal members, employees and their Nesika covered dependents.

The tribe has chosen not to have their providers acquire hospital privileges due to the fact that such privileges would require our providers seeing the community-at-large patients. In order to hold hospital privileges, providers are required to also be "on-call" for the community-atlarge — meaning our providers would be responsible for caring for all emergency patients during specific "on-call" shifts. This is a huge liability for the tribe and would be outside our scope of work with providing healthcare.

Hospitalists (hospital-based providers) are now utilized in most hospital settings – including our own Mercy

Medical Center. The average community-based general/family practitioner sends patients who need hospitalization to the hospital where a hospitalist assumes their in-hospital care until they are discharged back to their primary care provider in his/her own private office.

# Q: When Will the Clinic Have Male Providers?

A: We have recently hired a full-time male family nurse practitioner, Bill Briggs, who has 18 years experience working with children and adults. He will join our staff and begin orientation to his new position the week of October 5 and will begin seeing patients October 13.

Also joining the Tribe, on a part-time basis, is Dr. Michael Harding, MD who is a board certified Emergency Medicine doctor. Dr. Harding has practiced in Oregon for the past 23 years and is a resident of Douglas County. He will begin seeing patients by mid-October.

# Q: Is the Tribe opening another clinic in Canyonville?

A: Yes! A satellite clinic, to the CCH&WC (Roseburg), will be opening in Canyonville the first week of November, 2009. You may call and make an appointment, with providers at this new clinic, by mid-October. We have 5 providers now that you can choose to see for your healthcare needs. All these providers will be available at both clinics. If you have a provider you prefer, ask to have an appointment with that provider at the clinic you prefer. This new clinic will be open Monday-Friday, from 8:30 AM – 5:00 PM.

All appointments require a purchase order prior to each visit. Purchase orders are date sensitive so if you are rescheduled or have to go back to finish a procedure you need a new purchase order number for the new date of service.

Properly filled out applications will be processed with the Tribal Chairman's signature and will be mailed back to you.

Tribal members are encouraged to maintain a current address at the Cow Creek Tribal Government Offices.

Those who have minor children who are not living in their households also should make sure their children's updated addresses are on file with the Tribal Government Office.
