NEEDS ASSESSMENT SURVEY

Recently appointment cards were mailed out to all heads of household for the purpose of scheduling available times to conduct the Tribal Needs Assessment Survey. Please send in cards to the tribal office for interview appointments. This survey is extremely important for future services for all tribal members.

TRIBAL PROGRAMS

Adult Vocational Training

Currently there are five Tribal members receiving assistance through the Adult Vocational Training Program. The areas of training are automotive technology, bookkeeping, accounting, business management. This program provides assistance to students who are planning to obtain a vocational skill within 24 months. For information please call the Tribal Office.

Higher Education Program

Presently ten tribal students are receiving funding through the Higher Education Program, with seven more making application. Some areas of study are psychology, Business Administration, Humanities, Nursing, and Computer Science. Higher education funds are quickly being obligated therefore, potential students are strongly encouraged to research additional avenues of financial aid rather than relying upon the Higher Education program as a primary source of funding. Current students and those intending to apply for both the Adult Vocational Training Program and the Higher Education Program must complete and submit a Financial Aid Form (FAF) to the College Scholarship Service. The FAF can be obtained through most Community Colleges and Universities and also through the Tribal Office.

Housing Improvement Program

Currently one category B (rehabilitation) and one category C (down-payment) are underway. Both are expected to be completed within the month of February.

Scheduled for the Spring and Summer of 1990 are two category D projects (new construction), one category C (down-payment), and one category A (minimal repairs). Barring any unforeseen incidents, a total of 6 tribal members will receive service for the 1990 year.
