Please state why you believe this individual is qualified and what he or she would have to contribute to the work of these committees. The individuals who are appointed will have to travel to meetings in the Roseburg or Canyonville areas, so time and transportation are considerations in the Board's appointments. Please address your letters to Sue Shaffer, Chairman, or to Kathryn Staiano, General Manager. All letters must be in before September 23rd.
