The John Young lawsuit was thrown out of court on April 27 1988 by Federal Judge James Ridden, bringing to a close the efforts by Tribal Dissidents to envalidate the Judgement Distribution Plan. In addition to dismissing the action, as had been requested by Tribal Attorney Dennis Whittlesey, the Judge stated that the claims filed by John Young, Amaryllis Freeman, Mary Howren, Janey Heusner, Rose Deardorff, and otheres should never have been filed and he lectured their attorney Craig Dorsey, for his conduct in bringing

such meritless cla s before the court.

Although these people cannot be stopped from filing new lawsuits, he cautioned Dorsey that future frivolous litagations would result in stiff sanctions being imposed against him and his clients, concluding that the penalities would be so severe that Dorsey "would be in a world of hurt".
