In the past, the tribe has been besieged with election problems, therefore, it was felt that for the 1991 Board of Directors election, it was expedient to have the election conducted by the Bureau of Indian Affairs. At this particular time, it is unknown if an election would fall under the tribal constitution, now being voted upon or whether it would be governed by the 1978 by-laws. In order to avoid confusion the Board of Directors developed regulations for both nominations and the election. They will suffice for this year and no doubt be the basis for the formation of a permanent election ordinance for 1992. The chairman and the vice-chairman met with the Area Tribal Operations Officer on this matter. Several existing tribal ordinances were reviewed and a framework structured, however, rather than hastily develop the ordinance, election registration log, etc., it was concluded that the regulations tribal members are presently being mailed would be viable.

The Siletz Agency is mailing out nominating and voting regulations to all tribal members of voting age (18 years of age and older as of August 11, 1991). Those members who did not get registered to vote in the tribal constitutional election will also receive a "Voter Registration Form". It needs to be completed and mailed back right away. In order to be registered and receive a ballot, the form must be received at the Siletz Agency office by 10:00 a.m. on July 12, 1991. It is the responsibility of each eligible voting member of the tribe to get their name on the election registration log. You are urged to carefully read the instructions.

IT IS MOST IMPORTANT THAT YOUR MAILING ADDRESS IS CORRECT_PLEASE NOTIFY THE OFFICE OF ANY ADDRESS CHANGE.

Now is the time for all tribal members who are eligible to be added to the official tribal roll published in the Federal Register, January 10, 1991, to get their enrollment applications completed and mailed to the tribal office. These will, for the most part, be babies who were born after October 26, 1987. They will be processed at the tribal level, then, upon passage of the constitution, can be placed on the permanent roll.
