CLASS III GAMING COMPACT UPDATE

The gaming compact signed by the Tribe and the State was received in Secretary Manuel Lujan's office on October 6, 1992. Under the Indian Gaming Regulatory Act, the Interior Department has 45 days in which to act on the compact. The final day for their action is November 20th and it is anticipated that the videos will be on the property shortly thereafter. At that time, the days of operation and the hours will increase. You will be kept informed as this progresses. Chairman Shaffer has met with the Secretary, his counsel and gaming officials within the BIA Central Office. Securing the machines is the next step in the process. Arrangements for the machines are presently being negotiated.
