## UPDATE ON TRIBAL I.D. CARDS

The Tribal Identification Cards are in the process of being printed and will soon be available to interested tribal members. There will be two basic cards. One will be for those who are under the age of 18. Permanent cards will be issued to those over 18. The cards will contain the following information:

Tribal members will be responsible for providing the proper sized picture. The dimensions should be 1 1/4" x 1 1/4", and the picture needs to be a clear close-up.

The card will be attached to a form that you will fill out with the necessary information for processing the card (SOCIAL SECURITY NUMBER, etc.) In order for cards to be uniform, this procedure must be followed. It will then be returned for the Chairman's signature and lamination.

Position #1:

**Bingo Caller** - Applicant must have outgoing personality, clear speaking voice and public speaking experience. Starting at \$5.50 per hour, approximately 28 hours per week. Mon, Thur., & Fri. - 5 p.m. to 10:30 p.m., Sat. & Sun. - 11 a.m. to 4:45 p.m.

Position #2:

**Slot Room Cashier** - Applicant must have heavy cashiering or bank teller experience and ability to use a calculator. Starting at \$5.25 per hour. Mon. thru Fri. - 11 a.m. to 5 p.m.

Position #3:
