FINAL ELDERLY ASSISTANCE PAYMENTS MADE

In the "Good News Department" is the report that all of the recipients of the Elderly Assistance from the Judgement Fund have now been paid. Consequently, the interest from that fund will now be used in the other programs as provided for in the federal law, P.L. Law 100-391.

CULTURAL RESOURCES

At the annual meeting of the National Congress of American Indians, a resolution was passed that: "The National Congress of American Indians does hereby put forth every effort to assist the Cow Creek Band of Jmpqua Tribe of Indians in the protection of their traditional sites." This resolution was passed with the assistance of long time friend Ray Apodaca, Chairman of the Human Rights Committee. Further, and of real significance, is that NCAI passed as their top priority for the next session of Congress a resolution that: Native American religious freedom is established and declared to be the top priority of NCAI in the Congress:, and that: "NCAI will sponsor a "Religious Freedom Summit" in Washington, D.C., at the Executive Council Meeting"......that: "NCAI calls upon the President to direct his administration officials to develop a unified, strong, and clear position in support of this legislation". (The legislation will advocate appropriate religious freedom protection). This movement broadens the support for our resolution and it is timely that ours was introduced at this time when a great deal of focus is being put on site protection.

THE YEAR, 1993 AND INTO 1994

As we end the year, the Tribe has much to be thankful for in the progress that has been made in business and development of the tribal property. As well, we can look forward to an exciting year ahead, with the expansion of the gaming facility and the jobs it will create. It is with pride that we can look back at the accomplishments that have been made.

We can look back on the year, also, with a sense of loss and sadness for the loved ones who have taken the final journey.....but again, we can look ahead to the little ones who have joined us. With the latest enrollment, the tribal membership is now 860.
